## ORDINANCE NO. 25-678

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Unplatted tracts in Sections 2, 11 and 12, all in Township 28 South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the intersection of the west line of West Street and the north line of 31st Street South; thence west to the east line of Interstate 235 right-of-way; thence southeasterly and easterly along said right-of-way to the east line of Meridian Avenue; thence north to the left bank of the Big Slough; thence westerly and northwesterly along said left bank to the west line of West Street; thence north to the point of beginning.

- B. McEwen 7th Addition in Section 7, Township 27 South, Range 2 East, more fully described as follows:

Beginning at the intersection of the east line of Woodlawn Blvd. and the south line of the St. Louis and San Francisco R.R. right-of-way; thence east along said right-of-way line to the east line of Block 3, McEwen 7th Addition; thence south and southwesterly along the east line of Blocks 3 and 2 in said Addition to the northeast corner of McEwen 6th Addition; thence westerly along the north line of said Addition to the east line of Woodlawn Blvd.; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance No. 25-663 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 25-679

AN ORDINANCE AUTHORIZING THE CONSTRUCTION OF  
LATERAL 107, SUBMAIN 5, SANITARY SEWER NO. 22,  
IN THE CITY OF WICHITA, KANSAS.

WHEREAS, by resolution duly adopted on the 27th day of December, 1960, the City Engineer of the City of Wichita was authorized and directed to prepare plans and specifications for the construction of a sanitary sewer more particularly described as follows:

Lateral 107, Submain 5, Sanitary Sewer No. 22,

and cause an estimate of the cost to be filed with the City Clerk for the construction of said sewer; and,

WHEREAS, such plans, specifications and estimate of cost have been filed with the City Clerk as provided for by resolution;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING  
BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That it is hereby declared to be a public necessity to construct Lateral 107, Submain 5, Sanitary Sewer No. 22, in the City of Wichita.

SECTION 2. That the Mayor by and with the consent of the Board of Commissioners shall appoint three disinterested appraisers, who shall proceed to appraise such lots and pieces of land as shall be liable for said special improvements, being all of the lots and pieces of land in said sewer benefit district as described by Ordinance No. 25-666 and that the said appraisement shall be returned to this Commission at their first meeting after the same has been completed.

SECTION 3. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.
