SECTION 1. That it is a public necessity to improve and reimprove Meridian Avenue from the South line of Builders 17th Addition to the Center line of 33rd Street South as follows:

The construction of a seven (7) foot asphaltic concrete pavement on both sides of a twenty-six (26) foot asphaltic concrete pavement and between said pavement and a two (2) foot gutter with curb; esphaltic concrete pavement to have a six (6) thich concrete hase with a two (2) inch asphaltic concrete wearing surface; the lase under the twenty-six (26) foot pavement to be forceased in thickness from five (5) inches to six (6) inches.

SECTION 2. The cost of said improvement and reimprovement shall be assessed to the City at large, as provided by law.

SECTION 3. This ordinance shall take effect and be in force from and after its publication once in the official City paper.

AN CRDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCHIS, PINCES AND THACES OF JANI WITTEN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING POLY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, percels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A. Two unplatted and contiguous tracts in the Northeast Quarter of Section 29, Township 27 South, Range 2 East of the 6th P.M., more fully described as follows:

Beginning at the intersection of the vest line of the Northeast quarter of Section 29, Township 27 South, Range 2 East of the 6th P.M., and the south line of Kellogg Avenue; thence east along the south line of Kellogg to the westerly right-of-vay of the Kansas Turnpike Authority; thence southerly and westerly along the Turnpike right-of-way to the west line of the North at Quarter of said Section 29; thence north to the point of beginning.

ORDINANCE NO. 25-879

AN ORDINANCE AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF A PENEWAL TEMPORARY NOTE OF THE CIT. OF WIGHIA, KANSAS, IN THE AMOUNT OF \$42,030.00, FOR THE PURPOSE OF RENEWING AND REFUNDING AN EQUAL PRINCIPAL AMOUNT OF THE CITY OF WICHITA, KANSAS.

WHEREAS, the City of Wichita, Kansas, has heretofore issued a renewal temporary note of Series 61 in the aggregate principal amount of \$260,020.00, for the purpose of renewing and refunding an equal principal amount of temporary notes of Series 61, which had theretofore been issued by the City of Wichita, Kansas, for the preliminary payment of certain costs and expenses of paying and otherwise improving certain streets and street intersections, and the improving and reimproving of certain streets as rejor traffic streets as described in the preamble to Ordinance No. 24-925, all of which improvements had theretofore been duly authorized by the Governing Body of the City of Wichita, Kansas; said rerevel temporary note being kenewal Temporary Note number 9, Series 61, dated December 1, 1960, due July 15, 1961, and callable on June 15, 1961, or at anytime thereafter and before maturity; and

WHEREAS, the cost of said improvements is to be paid for in whole or in part by the issuance of bonds; and

WHEREAS, Section 10=123, 1959 Supplement to the General Statutes of Kansas, 1949, provides for the manager of temporary notes and renewal temporary notes from time to time as required during the progress of said work to pay therefor; and

WEEREAS, the City of Wichita, Kansas, now desires to call all of the renewal temporary notes of Series 61, being Renewal Temporary Note No. 9, aggregating the principal amount of \$260,020.00, of which amount \$217,990.00 is to be called for payment on June 15, 1961, and paid from the proceeds of a bond sale, leaving the sum of \$42,030.00 to be refunded by the issuance of a renewal temporary note; and
