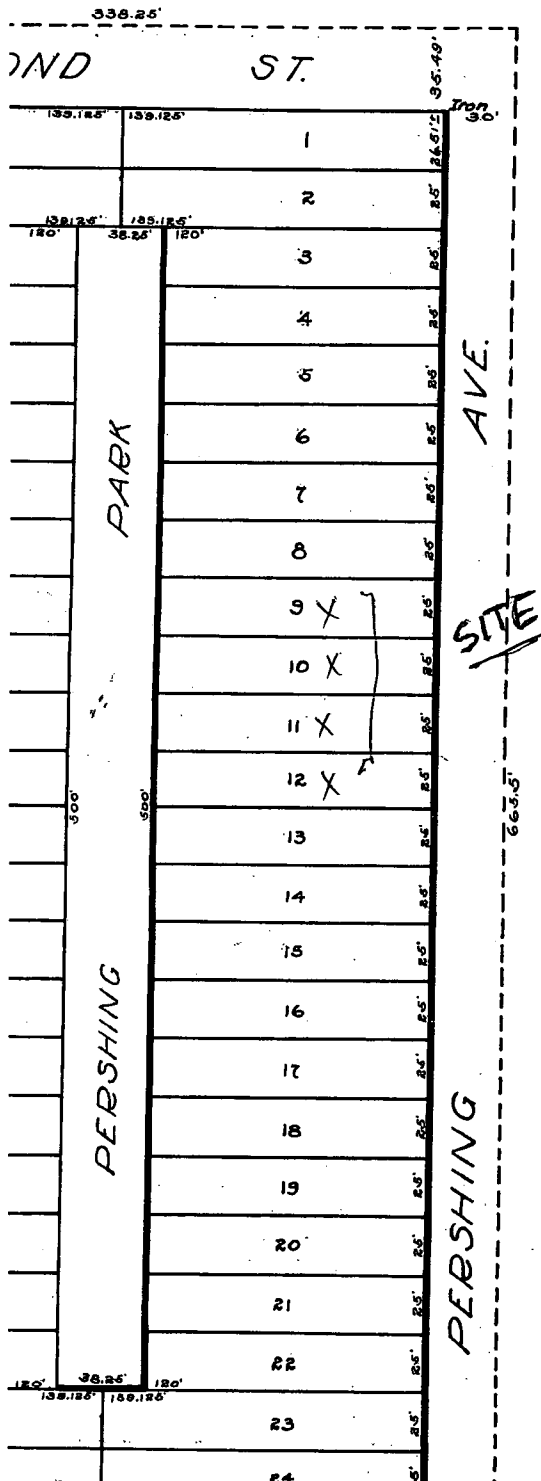


ERSHING TERRACE
