Legal Description: LOT 22, BLOCK 4, GLENN VILLAGE ADDITION to Wichita, Sedgwick County, Kansas. Generally located one-half mile south of Pawnee Avenue and one-half mile west of S. Seneca Street at the northwest corner of S. Glenn Avenue at W. 27th Street South (2757 S. Glenn Ave).

Dear Applicants:

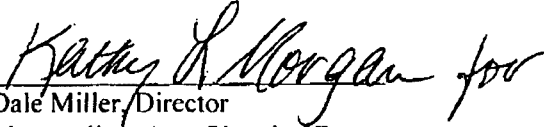
We have reviewed your request allow an electronic message center for an institutional use located at the corner of two collector streets. The LED sign will be directed to the northeast and southwest of the intersection.

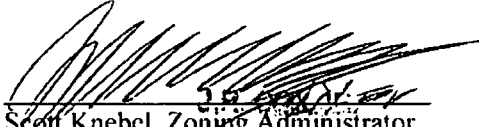
Our signatures below indicate that the electronic message center with the following conditions:

- 1) The administrative adjustment is for an LED sign only; all signage on the site shall otherwise conform to the Sign Code unless a separate adjustment or variance is approved.
- 2) The sign shall be in conformance with the approved site plan and elevation drawings. The sign shall be permitted and installed within one year from the date of approval (October 18, 2019).
- 3) No animated, flashing or moving images or text shall be displayed on the sign; the sign shall not make copy or graphics changes faster than once per second.
- 4) Portable signage shall not be permitted on the subject property.

- 5) If the Zoning Administrator finds that there is a violation of any of the conditions of the City of Wichita Sign Code, the Zoning Administrator, may, with the concurrence of the Planning Director, declare that the Sign Code Adjustment is null and void.

The development application sign should now be removed from the property.

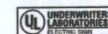
