AN ORDINANCE CHANGING THE ZONING CLASSIFICATIONS OR DISTRICTS OF CERTAIN LANDS LOCATED IN THE CITY OF WICHITA, KANSAS, UNDER THE AUTHORITY GRANTED BY THE WICHITA-SEDGWICK COUNTY UNIFIED ZONING CODE, SECTION V-C, AS ADOPTED BY SECTION 28.04.010, AS AMENDED.

BE IT ORDAINED BY THE GOVERNING BODY
OF THE CITY OF WICHITA, KANSAS.

SECTION 1. That having received a recommendation from the Planning Commission, and proper notice having been given and hearing held as provided by law and under authority and subject to the provisions of The Wichita-Sedgwick County Unified Zoning Code, Section V-C, as adopted by Section 28.04.010, as amended, the zoning classification or districts of the lands legally described hereby are changed as follows:

Case No. ZON2021-00024

City zone change from SF-5 Single-Family Residential to TF-3 Two-Family Residential zoning lot described as:

A tract of land located in the East half of the West half of the Northeast Quarter of Section 24, Township 28 South, Range 1 West of the 6th P.M., Sedgwick County, Kansas, more accurately described as follows:

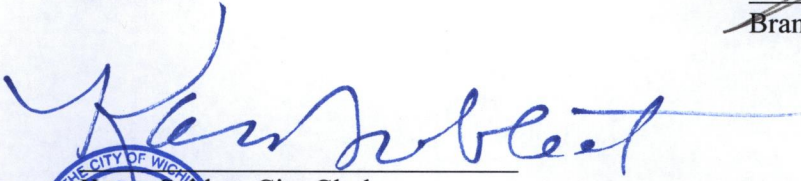
Commencing at the Northeast corner of the West half of the NE1/4 of SEC. 24, Twp. 28-S, R-1W;
Thence N89°14'05"W on the North line of said NE1/4 for a distance of 665.16 feet;
Thence S01°00'04"W perpendicular to the North line of said NE1/4 for a distance of 1571.41 feet to a Point of Beginning;
Thence continuing S01°00'04"E for a distance of 972.24 feet, to a point on the South line of said NE1/4;
thence on a curve to the left with a radius of 863.63', an arc length of 250.51 feet, and a chord bearing of S76°27'52"E, a distance of 249.64 feet;
Thence N88°57'17"E for a distance of 76.42 feet;
Thence N00°57'35"W for a distance of 1034.10 feet;
Thence S89°02'25"W for a distance of 318.80 feet to the Point of Beginning.

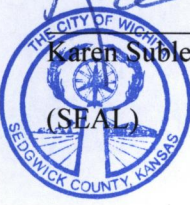

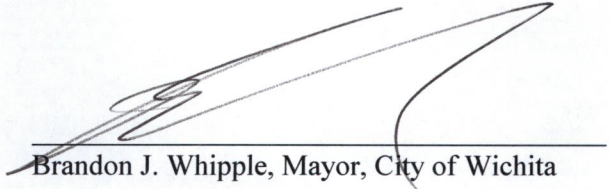
SECTION 3. That this Ordinance shall take effect and be in force from and after its adoption and publication in the official City paper.

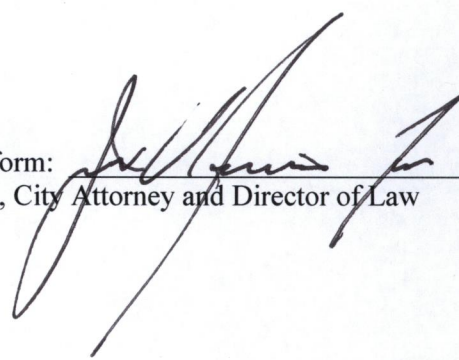

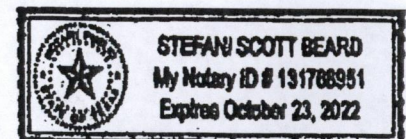
