Subject to the following provision as follows:

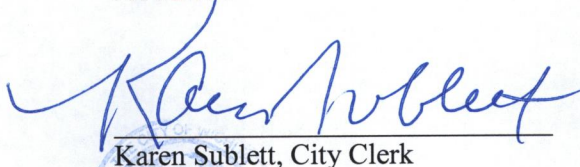
1. Execute document signed by Property Owner, MAPC Chairman and City Council terminating the covenant filed in conjunction with Z-3195.

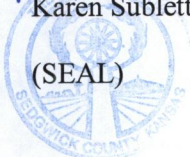

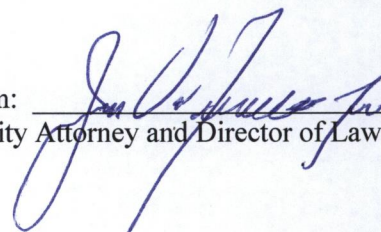

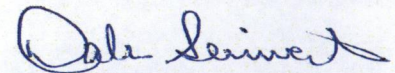
