The regular meeting of the Utility Advisory Committee will be held on Wednesday, November 13, 1957, at 1:45 p.m. on the second floor of the Police Academy Building, at which time the following items will be considered:

I. PRELIMINARY PLATS

- A. Womers Fourth Addition, an irregular area at the northeast corner of Charles and Clarence. (For reconsideration - no plat enclosed.)
- B. Lee-Moore Addition, an area on the west side of Clifton and in an area between Skinner and Mt. Vernon.

II. DEDICATIONS

- D-0018 - Dedication from Clarence M. Lemon and Violet I. Lemon for west 15 feet of Kessler from Newell north, more fully described as beginning 15 feet west of the southeast corner of Lot 9, Knight Acres, thence north to a point 337.7 feet south and 15 feet west of the northeast corner of said Lot 9, thence on a curve to the right with a radius of 217.26 feet to a point on the east line of said Lot 9 and 258.24 feet south of the northeast corner of said Lot 9, thence south along the east line of said Lot 9 to a point 15 feet east of beginning, thence west to beginning.
- D-0019 - Dedication from Allan D. Smith and JoAnne Smith for Richmond Street, described as follows: Beginning 623.88 feet north and 30.4 feet west of the southeast corner of the northeast quarter of northeast quarter of Section 13, Township 27 South, Range 1 West, thence west 30.4 feet, thence north 69.88 feet, thence east 30.4 feet, thence south to beginning.
