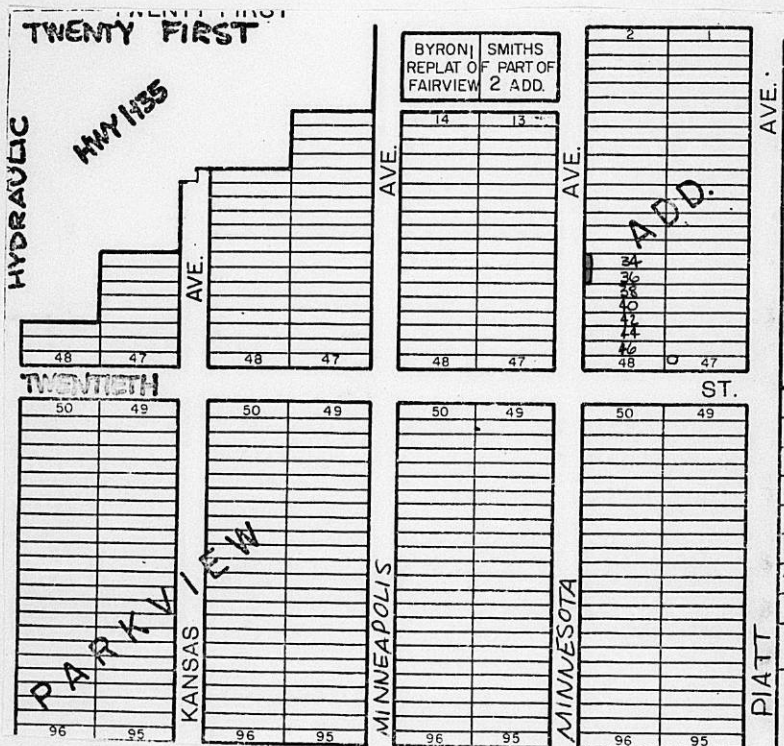

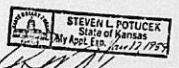

SUBJECT Subdivision Committee review of Parkview Addition properties legally described as follows:

5-8 Site 1 - Lots 34 and 36 on Herbert, now Minneapolis Parkview Addition

5-12 Site 2 - Lots 45 and 47 on Guy, now Piatt Avenue, Parkview Addition

On August 5, 1982, the Subdivision and Utility Advisory Committees reviewed the above-referenced City-owned land relative to public needs that should be satisfied prior to the sale of the properties. The following information and recommendations were provided:

Site 1:

1). Street right-of-way

Only 25 feet of half-street right-of-way exists for Minneapolis adjacent to this site. The Subdivision Committee acted to recommend that the west five feet of this site be dedicated for street purposes (proper form attached).

2). Granting additional utility easements:

Done The west 4 feet of the east 10 feet of these lots should be granted for utility easement purposes (proper form attached).

Site 2:

1). Street right-of-way:

The east five feet of this site should be dedicated for street purposes (proper form attached).

2). Granting additional utility easements:

Done The east 4 feet of the west 10 feet of these lots should be granted for utility easement purposes (proper form attached).
