

ORDINANCE NO. 34-478

AN ORDINANCE CHANGING THE NAME OF ELM STREET, EAST OF VASSAR AND WEST OF YALE, IN THE CITY OF WICHITA, TO SLEEPY HOLLOW DRIVE, AND REPEALING ALL ORDINANCES OR PARTS THEREOF WHICH ARE IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

That it is hereby declared to be in the interest and convenience of the public to eliminate confusion in the name of the following named street in the City of Wichita, and the name of such street should be, and the same is hereby changed from and after the effective date of this ordinance, and shall be known, named, and designated by the new name as follows, to-wit:

ELM STREET east of Vassar and west of Yale in the City of Wichita, be changed to SLEEPY HOLLOW DRIVE.

That all ordinances or parts thereof which are in conflict with this ordinance are hereby repealed.

That this ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.

Request for Street Name Change:

Request that Elm Street east of Vassar and west of Yale be changed to Sleepy Hollow Drive.

Description of Street Affected:

Elm Street beginning at a point on the north line of Elm Street and the east line of Vassar Avenue, which is the southwest corner of Lot 35, Grandview Terrace Addition, East two hundred fifty six and two tenths feet (256.2') to the southwest corner of Lot 15 Grandview Terrace Addition; which is the junction of Elm Street and Sleepy Hollow Drive, south seventy seven feet (77') along a line parallel with the east line of Vassar, west along a line parallel to north line of Elm to the east line of Vassar Avenue, north along the east line of Vassar to the point of beginning.

Reason for Change of Elm Street:

The City Commission action on August 26, 1975, provided for construction of a cul-de-sac on the west end of Elm Street and east of Vassar Avenue, with no access to Vassar from Elm Street. (copy of the cul-de-sac attached)

Upon completion of the cul-de-sac there will be no access to Elm Street except from Yale Street over a portion of Sleepy Hollow Drive.

A written request of the change from a landowner, Ed W. Ball (request attached).





Description of Street Affected:

Elm Street beginning at a point on the north line of Elm Street and the east line of Vassar Avenue, which is the southwest corner of Lot 35, Grandview Terrace Addition, East two hundred fifty six and two tenths feet (256.2') to the southwest corner of Lot 15 Grandview Terrace Addition; which is the junction of Elm Street and Sleepy Hollow Drive, south seventy seven feet (77') along a line parallel with the east line of Vassar west along a line parallel to north line of Elm to the east line of Vassar Avenue, north along the east line of Vassar to the point of beginning.

Reason for Change of Elm Street:

The City Commission action on August 26, 1975, provided for construction of a cul-de-sac on the west end of Elm Street and east of Vassar Avenue, with no access to Vassar from Elm Street. (copy of the cul-de-sac attached)

Upon completion of the cul-de-sac there will be no access to Elm Street except from Yale Street over a portion of Sleepy Hollow Drive.




