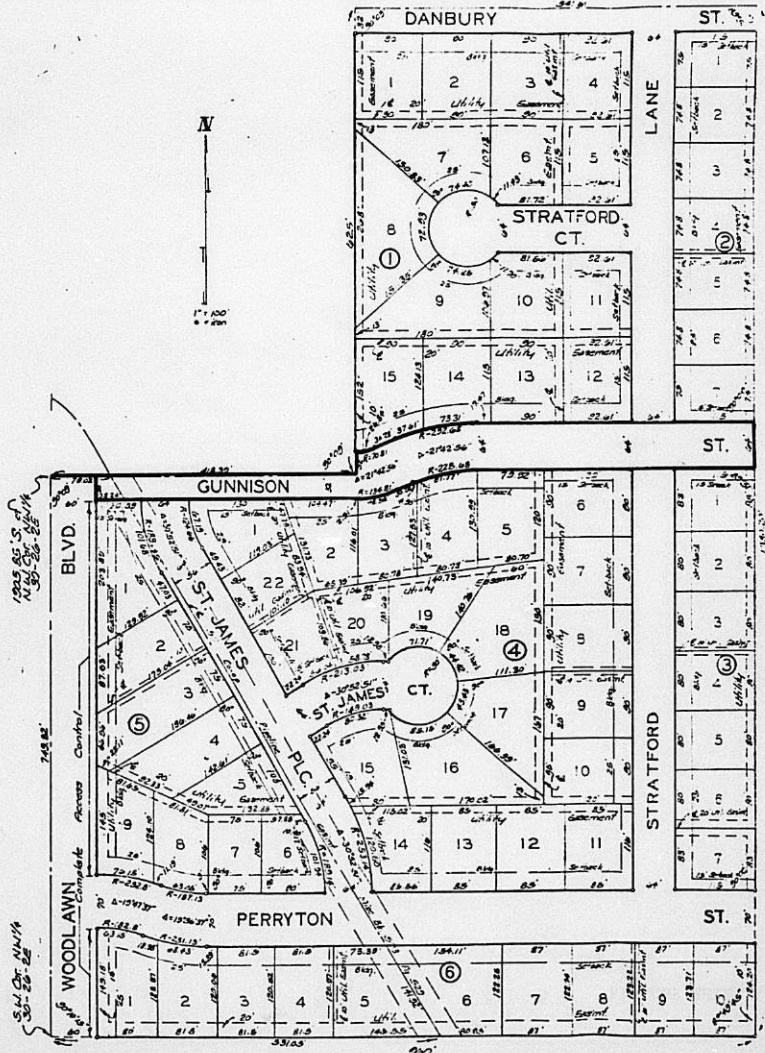

SECTION III. This Resolution shall take effect and be in force from and after its adoption and publication.





We are in receipt of your letter requesting the above referred to street names. In checking our maps of the area we note that Danbury Street in Bowers 1st Addition is also an east/west street while Danbury in Pearsons 1st Addition runs in a north/south direction. Should Danbury also be renamed?

Enclosed herewith is a small map of the area which shows how the street name problem came about in the Bowers Addition. As can be seen on the map, both Gunnison and Danbury in the Bowers Addition are logical extensions of these two streets which intersect with Woodlawn in an east/west alignment in the Pearsons Addition. If Danbury should also be changed, we would appreciate your advising us, and also what name this street should have in the Bowers Addition.

To simplify the numbering of this street and avoid confusion to those using the street we would request that the Gunnison in Bowers First Addition be changed to 42nd Street North.
