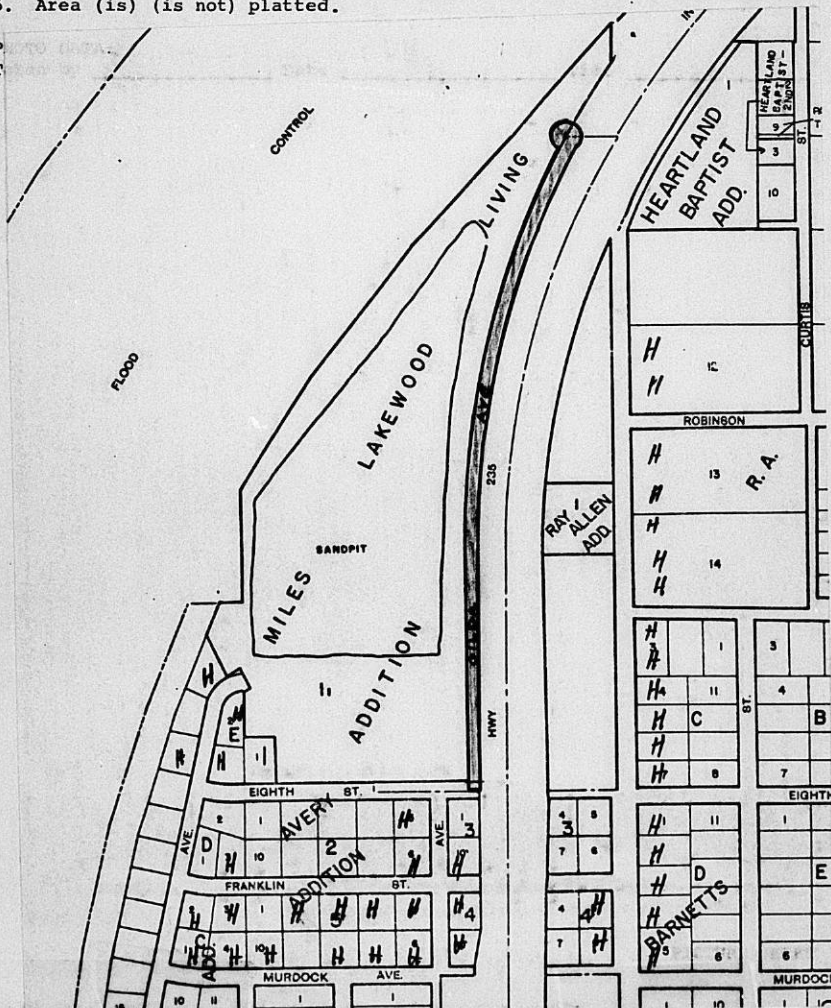

ORDINANCE NO. 38-328

AN ORDINANCE CHANGING THE NAME OF GILDA AVENUE AS PLATTED IN MILES LAKEWOOD LIVING, AN ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS, TO LAKEWIND AND REPEALING ALL ORDINANCES OR PARTS THEREOF WHICH ARE IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

That it is hereby declared to be in the interest and convenience of the public to eliminate confusion in the name of the following described street in the City of Wichita, and the name of such street should be, and the same is hereby changed from and after the effective date of this Ordinance, and shall be known, named and designated by the new name as follows, to-wit:

Gilda Avenue as platted in Miles Lakewood Living, An Addition to Wichita, Sedgwick County, Kansas, be changed to Lakewind.

That all Ordinances or parts thereof which are in conflict with this ordinance are hereby repealed.

That this Ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.

PASSED AND ADOPTED at Wichita, Kansas, this 26<sup>th</sup> day of April, 1983.

DR 83-5 - Request for name change for Gilda Avenue as  
platted in Miles Lakewood Living Addition.

In March of this year, the Planning Department received a written request from Gene Miles, owner of Miles Lakewood Living Addition, to change the street name of Gilda Avenue as platted in said addition to Lakewood Circle. Mr. Miles pointed out that Gilda Avenue north of Eighth Street in his subdivision is offset approximately 142 feet from the Gilda Avenue alignment south of Eighth Street. An area map is attached for your review.

The Subdivision Committee of the Metropolitan Area Planning Commission reviewed this street name change request at their regular meeting on March 31, 1983. Because of the other two existing Lakewood Streets in the County, the name of Lakewood Circle was not approved. Mr. Miles then proposed the name of "Lakewind Drive." After some discussion, the name of Lakewind (without the suffix "Drive") was recommended for approval. The Planning Commission concurred with this recommendation at their April 7th meeting.

This matter is scheduled for the Planning Agenda of the April 19th City Commission meeting. The recommended action is:

Approve the street name change from Gilda Avenue to  
Lakewind and place the ordinance on first reading.
