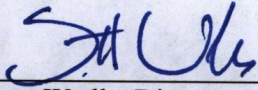

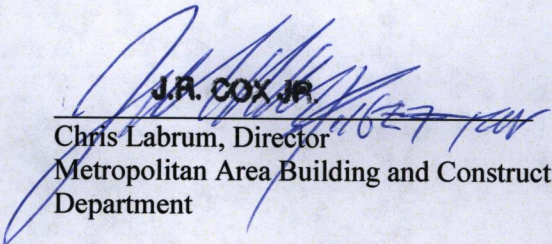
We have reviewed your request for a Zoning Adjustment to permit an accessory structure in front of the principal structure in addition to a front setback adjustment to reduce the front setback from 25 feet to 22 feet. Upon review of the case, it was discovered that the subject property was already approved for an accessory structure to be permitted in front of the principal structure per Administrative Adjustment BZA2019-00050. Additionally, the Zoning Administrator has interpreted that any structure permitted to be in front of the principal structure by Administrative Adjustment approval is allowed to be constructed within the front setback. Therefore, there is no need to request the adjustment for the front setback to be reduced.

Because it is determined that neither request is necessary, a full refund of the application fee has been processed. Since Mr. Guebara paid the application fee, the refund will be processed back to him in the form of a check. You can anticipate receiving the check by the end of the month.
