SUBJECT: Z-3051 - ZONE CHANGE FROM THE "BB" OFFICE DISTRICT TO
THE "C" COMMERCIAL DISTRICT, LOCATED ON THE WEST SIDE
OF WEBB ROAD, 800 FEET SOUTH OF HARRY. (District #3)

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

MAPC Recommendation: Approve "LC" zoning subject to voluntary
restrictive covenants limiting property to
"BB" uses and a car wash. (7-6)

Staff Recommendation: That request for "C" zoning be denied.

CPO Recommendation: CPO Council "3" recommended disapproval of the
request for "C" zoning. (5-0)
(Ora Nestleroad abstained).

Background: On May 7, 1992, the MAPC held a public hearing to
consider a zone change from the "BB" Office District to the "C"
Commercial District for Lot 2, Caliendo's 11th Addition. The property
is located on the west side of Webb Road, approximately 800 feet south
of Harry Street. The applicant has indicated that a car wash is the
intended use for the property.

The application area is currently vacant. The surrounding area has
been developed with low-intensity uses that primarily consist of
single-family residences. The current "BB" zoning allows various
residential uses and general offices which can be designed to be com-
patible with low-intensity residential uses. In addition to the nega-
tive impacts of noise and congestion associated with a car wash, the
requested "C" zoning permits a multitude of other high-intensity uses
that are inappropriate in this area.

RECOMMENDATIONS/ACTIONS: 1. Concur with the findings of the MAPC
and approve the zone change; place the
ordinance establishing the zone change
on first reading; or
2. Return the application to the MAPC for
reconsideration, stating reasons.

ORDINANCE NO. 41-763

AN ORDINANCE CHANGING THE ZONING CLASSIFICATIONS OR DISTRICTS OF CERTAIN LANDS LOCATED IN THE CITY OF WICHITA, KANSAS, UNDER THE AUTHORITY GRANTED BY SECTION 28.04.210, THE CODE OF THE CITY OF WICHITA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY
OF THE CITY OF WICHITA, KANSAS.

SECTION 1. That having received a recommendation from the Planning Commission, and proper notice having been given and hearing held as provided by law and under authority and subject to the provisions of Section 28.04.210, The Code of the City of Wichita, Kansas, the zoning classification or districts of the lands legally described hereby are changed as follows:

Case No. Z-3051
Zone change request from the "BB" Office
District to the "LC" Light Commercial
District

Lot 2, Caliendo 11th Addition, Wichita,
Sedgwick County, Kansas. Generally located
on the southwest corner of Harry and Webb
Road (1800 S. Webb Road).

SECTION 2. That upon the taking effect of the Ordinance, the above zoning changes shall be entered and shown on the "Official Zoning Map" previously adopted by reference, and said official zoning map is hereby reincorporated as a part of the Zoning Ordinance as amended.

SECTION 3. That this Ordinance shall take effect and be in force from and after its adoption and publication in the official City paper.
