REQUEST FOR ZONING

SCZ-0548 - ZONE CHANGE FROM THE "R" RURAL RESIDENTIAL
DISTRICT TO THE "R-1" SUBURBAN RESIDENTIAL DISTRICT.
GENERALLY LOCATED ON THE WEST SIDE OF SENECA, 1/4 MILE
NORTH OF 63RD STREET SOUTH.

The MAPC recommends that the application be approved.

ACTION:

1. Approve the recommendation of the Metro-
politan Area Planning Commission subject
to the conditions of platting, adopt a
resolution establishing the zone change
and instruct the Planning Department to
withhold publication until such time as
the plat has been recorded; or
2. Deny the application.

NOTE: A recommendation of denial by the City of Haysville Planning
Commission will require a unanimous vote by the Board of County Com-
missioners in order to approve the application.
