Dear Applicant,

At the **Thursday, June 26, 2025**, meeting of the Metropolitan Area Planning Commission (MAPC), the above-referenced vacation request was approved subject to the following conditions:

- (1) Provide Planning Staff with a legal description of the approved vacated portion of the platted taxiway easement on a Word document, via e-mail, to be used on the Vacation Order. This must be provided to Planning prior to the case going to City Council for final action.
- (2) Any relocation or reconstruction of utilities made necessary by this vacation shall be the responsibility and at the expense of the applicant. Provide Planning with any needed easements dedicated by separate instrument with original signatures. These conditions must be completed prior to the case going to Council for final action.
- (3) All improvements shall be according to City Standards and at the applicant's expense.
- (4) Per MAPC Policy Statement #7, all conditions shall be completed within one year of approval by the MAPC or the vacation request will be considered null and void. All vacation requests are not complete until the Wichita City Council or the Sedgwick County Board of County Commissioners have taken final action on the request and the Vacation Order and all required documents have been provided to the City, County and/or franchised utilities and the necessary documents have been recorded with the Register of Deeds.

These conditions have been met. Therefore, this case is scheduled for final action by the Wichita City Council on **Thursday, August 7, 2025**. This letter also serves as a reminder that the vacation notification signs should now be removed from the property. 5. The vacation of the described taxiway easement, should be approved.

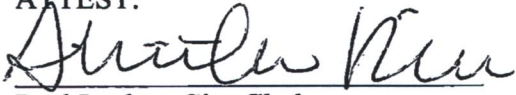

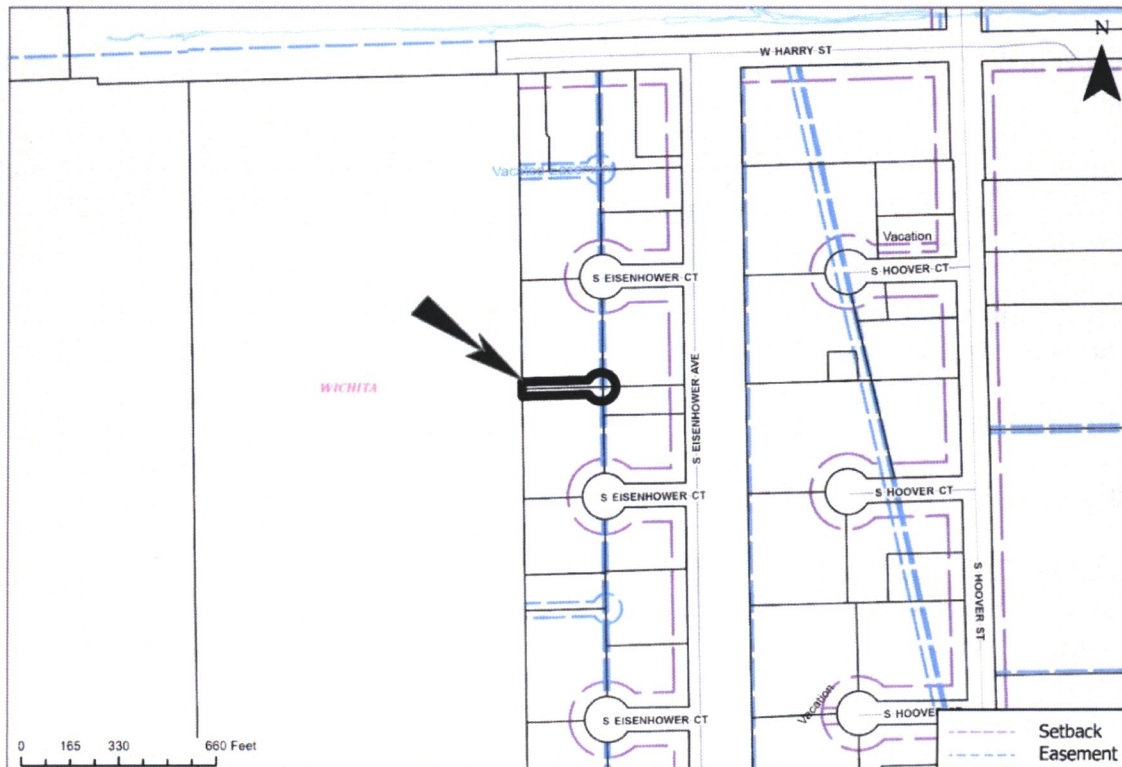

STAFF REPORT

- CASE NUMBER:** VAC2025-00021 - City vacation of platted taxiway easement
- OWNER/APPLICANT:** 1631 S. Eisenhower LLC; Smith Construction; CGA Properties, LLC; Christopher & Debbie Ballinger
- LEGAL DESCRIPTION:** Vacating the 50-foot-wide platted taxiway easement running east – west and common to Lots 3, 4, 11, 12, Block 1, Airport Industrial Park Addition, Wichita, Sedgwick County, Kansas.
- LOCATION:** Generally located approximately one-quarter mile southwest of the intersection of West Harry Street and South Hoover Street (1631 South Eisenhower Ct).
- REASON FOR REQUEST:** Remove encumbrances due to the absence of a taxiway or plans for a taxiway
- CURRENT ZONING:** The subject site and all abutting and adjacent properties are zoned LI Limited Industrial District (LI). All abutting and adjacent LI zoned properties are mostly developed as small manufacturing and/or office warehouse.
- VICINITY MAP:**



The applicants have requested the vacation of the common 50-foot platted taxiway easement on property generally located approximately one-quarter mile southwest of the intersection of West Harry Street and South Hoover Street. The property is addressed 1651 South Eisenhower Court and is zoned LI Limited Industrial District (LI). The purpose of this request is to remove encumbrances due to the absence of a taxiway or plans for a taxiway. Case VAC2023-00012 likewise approved a taxiway easement vacation at 1631 South Eisenhower Ct.

There are no platted setbacks located along the common lot line of the above-mentioned properties; setbacks are according to the Unified Zoning Code's LI zoning district. There is a platted 16-foot sewer easement that crosses the subject taxiway easement. A sewer line is located in this easement. The sewer easement will remain.

There are no additional public utilities in the vacation area. Wichita Public Works and Utilities, Fire, Stormwater, or Traffic Engineering do not object to this vacation. Comments from franchised utilities have been received. Neither Cox, Evergy, nor Kansas Gas object to the vacation. They do not have any lines or equipment in the vacation area. The Airport Park Industrial Addition was recorded December 18, 1964.

Evergy has no items in the areas the applicant is requesting to vacate and therefore has no objection. Nick Hensley, Area Design Representative, will be the contact for this vacation request and any project associated with it. He can be contacted at (316) 261-6320. Standard language applies: **Any relocation or removal of existing Evergy equipment will need to be discussed and will be at the applicant's expense. No transmission in the area.**

Based upon information available prior to the public hearing and reserving the right to make recommendations based on subsequent comments from Public Works, Stormwater, Water and Sewer, Traffic, Fire, franchised utility representatives and other interested parties, planning staff has listed the following considerations (but not limited to) associated with the request to vacate the described platted taxiway easement.

- A. That after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, the MAPC makes the following findings:
1. That due and legal notice has been given by publication as required by law, in the Wichita Eagle, of notice of this vacation proceeding one time June 5, 2025, which was at least 20 days prior to this public hearing.
 2. That no private rights will be injured or endangered by vacating the described portion of the platted taxiway easement and that the public will suffer no loss or inconvenience thereby.
 3. In justice to the petitioner, the prayer of the petition ought to be granted.

Conditions (but not limited to) associated with the request:

- (1) Vacate the described platted taxiway easement. Provide planning staff with legal descriptions of the approved vacated portion of the platted taxiway easement on a Word document, via e-mail, to be used on the Vacation Order. This must be provided to Planning prior to the case going to Council for final action.

- (2) Any relocation or reconstruction of utilities made necessary by this vacation shall be the responsibility and at the expense of the applicant. Provide Planning with any needed easements dedicated by separate instrument with original signatures. These conditions must be completed prior to the case going to Council for final action.
- (3) All improvements shall be according to City Standards and at the applicant's expense.
- (4) Per MAPC Policy Statement #7, all conditions shall be completed within one year of approval by the MAPC or the vacation request will be considered null and void. All vacation requests are not complete until the Wichita City Council or the Sedgwick County Board of County Commissioners have taken final action on the request and the vacation order and all required documents have been provided to the City, County and/or franchised utilities and the necessary documents have been recorded with the Register of Deeds.
