

RECOMMENDATION FROM METROPOLITAN AREA PLANNING COMMISSION
TO BOARD OF COUNTY COMMISSIONERSREQUEST FOR ZONING

SCZ-0541 - ZONE CHANGE FROM THE "R" RURAL RESIDENTIAL AND THE "R-1" SUBURBAN RESIDENTIAL DISTRICTS TO THE "E" LIGHT INDUSTRIAL DISTRICT. GENERALLY LOCATED ON THE NORTH SIDE OF 45TH STREET NORTH BETWEEN ROCK AND WEBB ROAD.

The MAPC recommends that the application be denied.

1. Approve the recommendation of the Metropolitan Area Planning Commission and the Bel Aire Planning Commission and deny the application; or
2. Adopt a resolution establishing the zone change, and instruct the Planning Department to withhold publication until such time as the property has been platted and the plat has been recorded.
