

RECOMMENDATION FROM METROPOLITAN AREA PLANNING COMMISSION
TO BOARD OF COUNTY COMMISSIONERS

REQUEST FOR ZONING

SCZ-0587 - ZONE CHANGE FROM THE "R-1" SUBURBAN RESIDENTIAL DISTRICT
TO THE "AA" ONE-FAMILY DWELLING DISTRICT. LOCATED ON THE WEST SIDE OF
127TH STREET EAST, APPROXIMATELY 1/3-MILE NORTH OF CENTRAL.

The MAPC recommends that the application be approved subject to platting the property within two years.
