RESOLUTION NO.

A RESOLUTION CHANGING THE ZONING CLASSIFICA-TION FOR CERTAIN LANDS LOCATED WITHIN THE UNINCORPORATED AREA OF SEDGWICK COUNTY, KANSAS, UNDER THE AUTHORITY GRANTED IN SECTION 17.C OF THE ZONING REGULATIONS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, DECEMBER 12, 1984, AND SUBSEQUENTLY AMENDED.

BE IT RESOLVED BY THE GOVERNING BODY OF SEDGWICK COUNTY, KANSAS.

SECTION I. That after receiving a recommendation from the Wichita-Sedgwick County Metropolitan Area Planning Commission, and after said Planning Commission has given proper notice and held a public hearing as provided by law, and under authority granted by Section 17.C of the Zoning Regulations, the zoning district of the lands legally described below are hereby changed as follows:

Zone change request from the "R-1" Suburban Residential District to the "E" Light Industrial District

Beginning 480 feet west of the northeast corner of the Northwest Quarter of the Southwest Quarter; thence west 120 feet; thence south 181 feet; thence east 120 feet; thence north to the point of beginning, Section 34, Township 28 South, Range 1 East of the 6th P.M., Sedgwick County, Kansas. Generally located 580 feet east of Hydraulic on the north side of 68th Street South (1902 E. 68th St. S.).

SECTION II. That upon the taking effect of this Resolution, the notation of such zone change shall be entered in the official zoning atlas on file in the Office of the County Zoning Administrator and in the Office of the Wichita-Sedgwick County Metropolitan Area Planning Department.

SECTION III. That this Resolution shall take effect and be in force from and after its adoption and publication in the official county paper.
