AN ORDINANCE CHANGING THE ZONING CLASSIFICATIONS OR DISTRICTS OF CERTAIN LANDS LOCATED IN THE CITY OF WICHITA, KANSAS, UNDER THE AUTHORITY GRANTED BY SECTION 17.C OF THE ZONING REGULATIONS FOR THE UNINCORPORATED AREA OF SEDGWICK COUNTY, KANSAS AND SECTION 28.04.160(A), THE CODE OF THE CITY OF WICHITA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS.

**SECTION 1.** That having received a recommendation from the Planning Commission, and proper notice having been given and hearing held as provided by law and under authority and subject to the provisions of Section 17.C of the Zoning Regulations for the Unincorporated Area of Sedgwick County, Kansas and Section 28.04.160(A), The Code of the City of Wichita, Kansas, the zoning classification or districts of the lands legally described hereby are changed as follows:

## Case No. Z-3105 (formerly SCZ-0639)

Zone change request from the "E" Light Industrial District to the "AA" One-Family Dwelling District.

All that part of the Southeast Quarter of Section 11, Township 28 South, Range 1 West of the 6th P.M., Sedgwick County, Kansas, lying north of a line of 1,133 feet north of the south line of said Southeast Quarter and west of the west line of the Missouri Pacific Railroad right-of-way, being platted as Lot 3, Block 1, Criss Optical Addition, Wichita, Sedgwick County, Kansas.

Generally located on the north side of MacArthur between West Street and Hoover Road.

**SECTION 2.** That upon the taking effect of the Ordinance, the above zoning change shall be entered and shown on the "Official Zoning Map" previously adopted by reference, and said official zoning map is hereby reincorporated as a part of the Zoning Ordinance as amended.

**SECTION 3.** That this Ordinance shall take effect and be in force from and after its adoption and publication in the official City paper.
