REQUEST FOR ZONING

SCZ-0633 - REQUEST FOR ZONE CHANGE FROM "C" GENERAL COMMERCIAL AND "R-1" SUBURBAN RESIDENTIAL DISTRICTS TO THE "C" GENERAL COMMERCIAL DISTRICT, LOCATED ON THE EAST SIDE OF SENECA BETWEEN 61ST STREET SOUTH AND WALLINGFORD.

The MAPC recommends that the application be approved, subject to conditions (see minutes for full motion).

Parsons moved, Winkler seconded, and it carried with unanimously. Breckenridge, Goebel, Hunt and Miles were absent.

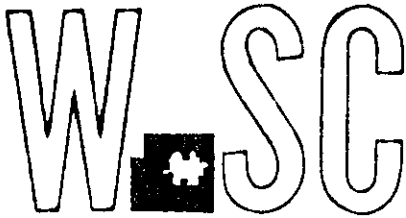
