

RECOMMENDATION FROM METROPOLITAN AREA PLANNING COMMISSION  
TO BOARD OF COUNTY COMMISSIONERS

REQUEST FOR ZONING

SCZ-0679 - REQUEST FOR ZONE CHANGE FROM THE "R" RURAL RESIDENTIAL DISTRICT TO THE "E" LIGHT INDUSTRIAL DISTRICT, LOCATED AT THE NORTHEAST CORNER OF CENTRAL AND MAIN IN THE UNINCORPORATED TOWN OF GREENWICH.

The MAPC recommends that the application be denied. Miner moved, Lopez and it carried with a vote of 10 in favor (Miner, Lopez, Frye, Goebel, Haggar, McKay, Phillips, Polczynski, Sherman and Ross), and 1 opposed (Wheeler). Johnson and Osborne-Howes were absent. One vacancy.

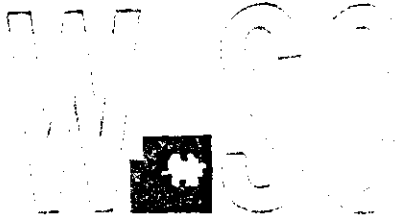
