TO BOARD OF COUNTY COMMISSIONERS

REQUEST FOR ZONING

SCZ-0669 - REQUEST FOR ZONE CHANGE FROM THE "R-1" SUBURBAN
RESIDENTIAL DISTRICT TO "AA" ONE FAMILY DWELLING DISTRICT, LOCATED
ON THE WEST SIDE OF 143RD STREET EAST BETWEEN SUNDANCE AND THE
BURLINGTON NORTHERN RAILROAD TRACTS.

The MAPC recommends that the application be approved, subject to platting within one year. Phillips moved, Sherman seconded and it carried unanimously. Osborne-Howes and Roberts were not present. Goebel and Lopez were absent.

ACTION: 1. Adopt the findings of fact of the Metropolitan Area Planning Commission and approve the zone change subject to the condition of platting; adopt a resolution establishing the zone change and instruct the Planning Department to withhold publication until the plat has been recorded with the Register of Deeds; or

2. Return to the Planning Commission for reconsideration.

(An override of the Planning Commission's recommendation requires a 2/3rd majority vote of the membership of the governing body on first reading).

RESOLUTION NO. 95-1994

A RESOLUTION CHANGING THE ZONING CLASSIFICATION FOR CERTAIN LANDS LOCATED WITHIN THE UNINCORPORATED AREA OF SEDGWICK COUNTY, KANSAS, UNDER THE AUTHORITY GRANTED IN SECTION 7.C OF THE ZONING REGULATIONS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, DECEMBER 12, 1984, AND SUBSEQUENTLY AMENDED.

BE IT RESOLVED BY THE GOVERNING BODY OF SEDGWICK COUNTY, KANSAS.

SECTION I. That after receiving a recommendation from the Wichita-Sedgwick County Metropolitan Area Planning Commission, and after said Planning Commission has given proper notice and held a public hearing as provided by law, and under authority granted by Section 17.C of the Zoning Regulations, the zoning district of the lands legally described below are hereby changed as follows:

Zone change request from the "R-1" Suburban Residential District to the "AA" One Family Dwelling District

A tract of land in the east 1/2 of the S.E. 1/4 of Section 11, Township 27 South, Range 2 East of the 6th P.M. and described as: Commencing at the N.E. Corner of said S.E. 1/4; thence bearing S0° 00' 00"E along the east line of said S.E. 1/4 a distance of 111.24 feet to the point of beginning; thence bearing N89° 58' 39"W along the south right-of-way line of the St. Louis Wichita and Western Railroad Co. a distance of 1321.82 feet to a point in the west line of the east 1/2 of said S.E. 1/4; thence bearing S0° 04' 45"W a distance of 955.67 feet; thence bearing N90° 00' 00"E a distance of 712.17 feet; thence bearing N40° 56' 36"E a distance of 266.39 feet; thence bearing N90° 00' 00"E a distance of 436.40 feet to a point on the east line of said S.E. 1/4; thence along said east line bearing N0° 00' 00"E a distance of 753.93 feet to the point of beginning. SECTION III. That this Resolution shall take effect and be in force from and after its adoption and publication in the official county paper.
