RECOMMENDATION FROM MAPC TO BOARD OF CITY COMMISSIONERS

V-1279 - VACATION OF AN 8-FOOT UTILITY EASEMENT GENERALLY LOCATED
ON THE EAST SIDE OF MCCOMAS SOUTH OF HARRY STREET.

Note: The City Clerk will certify as to proper publication
of notice of hearing and filing of written protest.

A petition for the above identified vacation request has been filed
in the office of the City Clerk. The Planning Commission recommends that
the Board of City Commissioners find that no private rights will be injured
or endangered and the public will suffer no loss or inconvenience by granting
by order the vacation request subject to:

- A. Proper publication of notice of public hearing.
- B. The absence of proper written protest filed with the City Clerk.
- C. All proceedings being without cost to the City, County, or any
utility company.
- D. Any relocation or reconstruction of utilities necessitated by this
vacation shall be at the sole expense of the applicant.

Bayouth moved, Goebel seconded and it carried unanimously. Banzer was
absent. Gardner was not yet present (8-9-84).

ACTION:

Close the public hearing, approve the
vacation request, authorize the Mayor
to sign the vacation order and instruct
the City Clerk to file a certified copy
