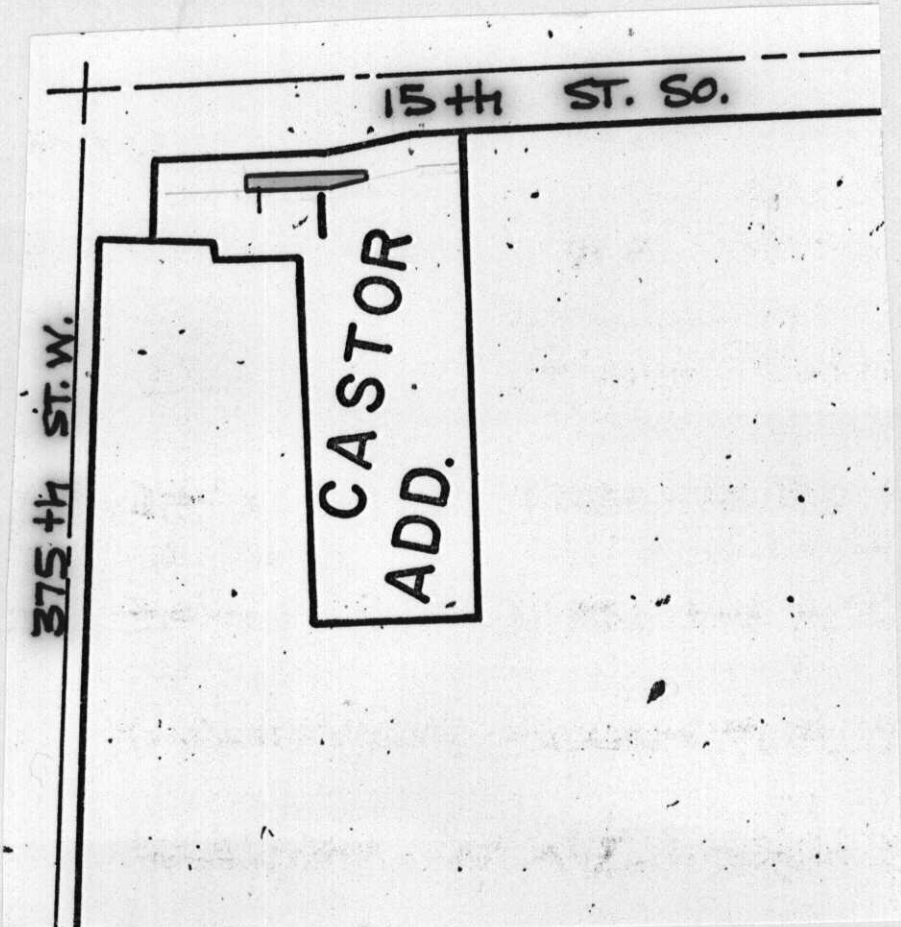

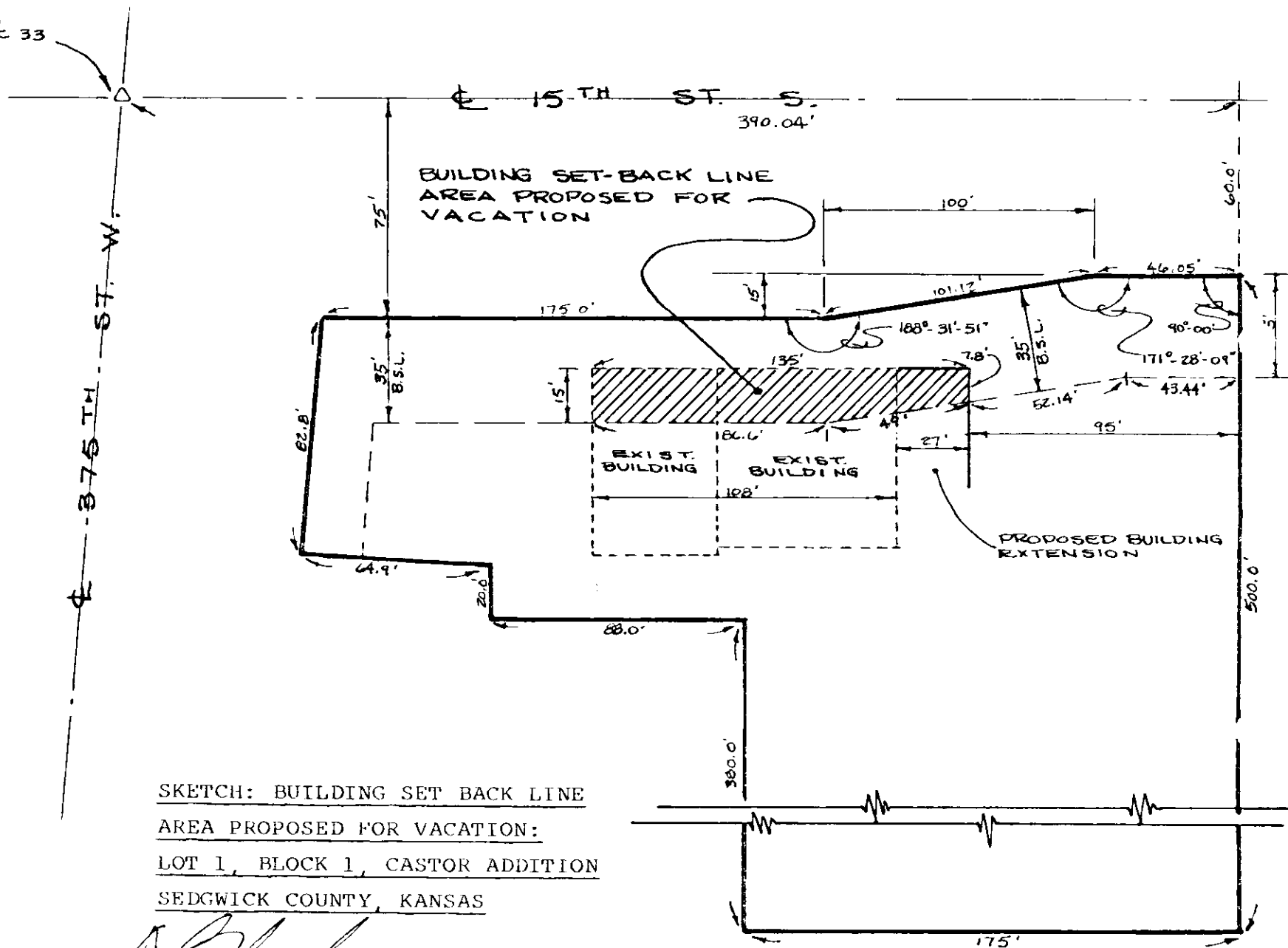

WHEREUPON, it is shown that proper notice has been given by
publication in the _____, a newspaper printed in
the State of Kansas and being published in and for general circulation
in Sedgwick County, Kansas, the first publication being made on the
_____, day of _____, 19__, and proper proof of such
publication being filed herein. The Board being advised in the pre-
mises finds that such notice is in due legal form and conforms to K.S.A.
1970 Supp. 12-504.

THEREAFTER, the matter is presented to the Board and the Board
finds that no private rights will be injured or endangered by such
vacation and that the public will suffer no loss or inconvenience
thereby, and that in justice to the petitioners, their prayer should
be granted and that no written objections have been filed hereto with
the County Clerk.

EXHIBIT "A"

"Commencing at a point on the east line of Lot 1, Block 1, Castor Addition, Sedgwick County, Kansas, which is 35.0 feet south of the northeast corner of said Addition, said point being on the building setback line along the north side of said Addition; thence west along said setback line, a distance of 43.44 feet; thence to the left $8^{\circ}-31'-51''$ along said setback line, 52.14 feet, to the point of beginning; thence continuing along the previous course and along said building setback line, 49 feet; thence to the right $8^{\circ}-31'-51''$ and west along said setback line, 86.6 feet; thence north parallel to the east line of said plat, 15 feet; thence east parallel to the north line of said plat, 135 feet; thence south, parallel to the east line of said plat, 7.8 feet, to the point of beginning."
