

RECOMMENDATION FROM MAPC TO BOARD OF CITY COMMISSIONERS

ORDINANCE NO. 38-763

AN ORDINANCE VACATING THE NORTH 180 FEET OF THE 10-FOOT UTILITY EASEMENT CENTERED ON THE COMMON LOT LINE OF LOTS 12 AND 13, BLOCK 1, COUNTRY PLACE ESTATES, WICHITA, SEDGWICK COUNTY, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the utility easement described as follows,
to-wit:

The north 180 feet of the 10-foot utility easement centered on the common lot line of Lots 12 and 13, Block 1, Country Place Estates, Wichita, Sedgwick County, Kansas; (MAPC NO. V-1246);

be and the same is hereby vacated in accordance with K.S.A. 13-443, subject, however, to the concurrence in such vacation by the Board of County Commissioners as by law provided.

SECTION 2. That it is hereby recommended to the Board of County Commissioners of Sedgwick County, Kansas, that said above described easement be vacated by said Board in case a proper petition is filed under the provisions of K.S.A. 12-504, 12-505 and K.S.A. 12-506.

SECTION 3. That this Ordinance shall be in force and take effect from and after its passage and publication once in the official city paper.
