SUBJECT: V-1368 - VACATION OF COMPLETE ACCESS CONTROL,
GENERALLY LOCATED AT THE SOUTHEAST CORNER OF
CENTRAL AND EISENHOWER.

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

MAPC Recommendation: Approve vacation of complete access control.

Background: Diamond Head of Wichita, Inc., c/o Chung Wah Cheng, 3137-220 South Seneca, Wichita, KS 67217, has requested this vacation of access control to permit a driveway to Central. The "complete access control" being vacated was dedicated by a previous owner of the property. This access control was dedicated in order to avoid special assessments associated with the improvement of Central Avenue. The Engineering Division requested that a condition of vacation case approval be the reimbursement of approximately \$3,800.00 to cover the cost of special assessments not levied against the subject property because of the existence of the "complete access control". The Planning Commission did not, however, make this a requirement of vacation case approval.

Analysis: The Planning Commission recommends the City Commission find: (1) that no private rights will be injured or endangered; and (2) the public will suffer no loss or inconvenience by granting by order the vacation, subject to:

1. Proper publication of notice of public hearing;
2. The absence of proper written protest filed with the City Clerk;
3. All proceedings being without cost to the City, County or any utility company;
4. Any relocation or reconstruction of utilities necessitated by this vacation shall be at the sole expense of the applicant;
5. The Vacation Order shall retain "Access control except for one opening" to Central, across the north line of the subject lot; and
6. The applicant shall execute a petition for the paving of Eisenhower Street from the south line of Central to the south line of Lot 1, Suter Addition.

Legal Considerations: The City Clerk certifies as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing; approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to owner.

5. "Access control except for one (1) opening" is hereby retained.
6. The vacation of the access control described herein should be approved.

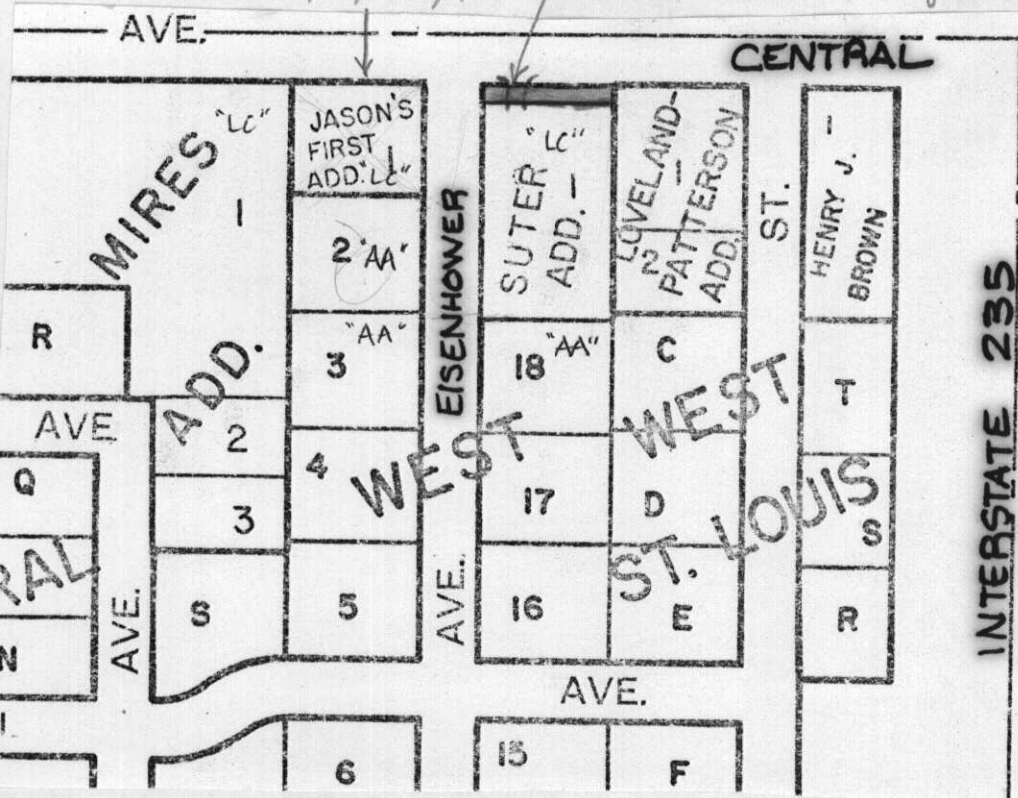
