SUBJECT: V-1505 - REQUEST TO VACATE A PORTION OF A PLATTED BUILDING
SETBACK, LOCATED IN AN AREA SOUTH OF GREENBRIAR, ON THE
EAST SIDE OF ROCK ROAD. (District #2)

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of building setback

MAPC Recommendation: Approve vacation of building setback. (unanimous)

Background: The applicant wishes to construct houses closer to the masonry wall that buffers the subject building sites from Rock Road. This vacation case will reduce the setback down to the standard 15-foot sideyard setback. The planned houses will not be constructed so as to front onto or be accessed from Rock Road. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing; approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order; recording costs to be billed to:

NOW on this 8th day of December, 1987, comes on for hearing the petition for vacation filed by Slawson Investment Corporation, praying for the vacation of the following described portion of a platted building setback, to-wit:

The east 5 feet of the 25-foot setback along the west line of Lots 13, 14, 19 and 20, Block 1, Penstemon 4th Addition to Wichita, Sedgwick County, Kansas, except the north 50 feet of Lots 14 and 20 and the south 50 feet of Lots 13 and 19.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on NOV. 25 & DEC 2, 1987.

2. No private rights will be injured or endangered by the vacation of the above-described building setback, and the public will suffer no loss or inconvenience thereby.

3. In justice to the petitioner(s) the prayer of the petition ought to be granted.

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.

5. The vacation of the building setback described herein should be approved.

IT IS, THEREFORE, BY THE CITY COUNCIL, on this 8th day of December, 1987, ordered that the above-described building setback is hereby vacated. IT IS FURTHER ORDERED that the City Clerk shall certify a copy of this order to the Register of Deeds of Sedgwick County.
