Staff Recommendation: Approve vacation of utility easement.

Background: The applicant has requested this vacation in order to clear title to the property as an existing structure is in a utility easement. The Utility Advisory Committee and City Engineering has indicated that no adverse effects will result by the vacation of this utility easement.
