STREET NORTH, LOCATED IN AN AREA EAST OF MAIZE ROAD AT 17TH
STREET NORTH

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

MAPC Recommendation: Approve vacation of street right-of-way.

Background: The Catholic Diocese of Wichita is requesting this vacation of street right-of-way to satisfy a condition of approval for Amarado Estates Third Addition.

Analysis: The Planning Commission recommends City Council adopt a resolution recommending that the County Commission approve this vacation subject to:

- I. Any relocation or reconstruction of utilities necessitated by this vacation shall be at the sole expense of the applicant.

Legal Considerations: This request for vacation is located on property outside the City of Wichita, but within three miles thereof. As such, no petition, publication of notification or public hearing is required before the City Council.

Recommendations/Action: Approve vacation; adopt resolution;

The north 40 feet of the Northwest Quarter of the Southwest
Quarter of Section 8, Township 27 South, Range 1 West of
the 6th P.M., Sedgwick County, Kansas, except the west 50
feet thereof.

WHEREAS, there has been filed in the office of the Wichita-
Sedgwick County Metropolitan Area Planning Department, proceedings for the
vacation of street right-of-way described as:

feet thereof.

Be and the same is approved for vacation.

SECTION 2. That it is hereby recommended to the Board of
County Commissioners of Sedgwick County, Kansas, that the said above-
described street right-of-way be vacated in the event that a proper petition
is filed under the provisions of Kansas Statutes Annotated, 58-2613, 58-2614
and 58-2615.

SECTION 3. That this resolution shall be in force and take effect
from and after its passage and publication once in the official city paper.

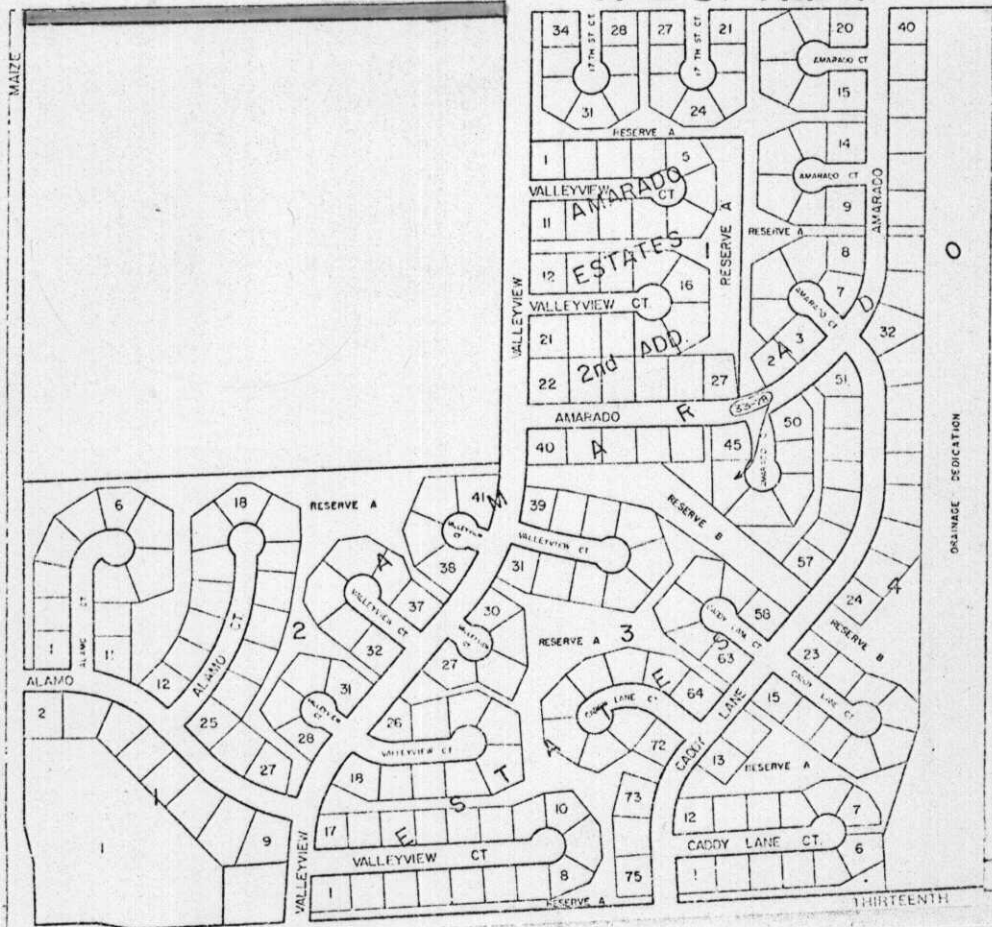
