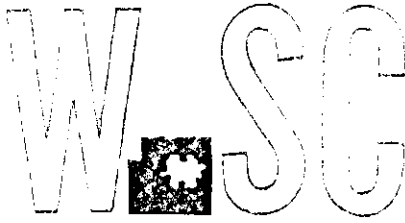

Gentlemen:

At the regular meeting of the Subdivision Committee of the Metropolitan Area Planning Commission, Thursday, June 30, 1988, the above-captioned vacation request was considered. The action of the Committee was to recommend that this vacation be approved subject to:

- A. Any relocation or reconstruction of utilities necessitated by this vacation shall be at the sole expense of the applicant.
- B. The applicant shall guarantee the abandonment of an existing water line within the easement requested for vacation. Records in the Water Department shows there is a 6" water main (water value #16127) within the utility easement. This guarantee shall provide for removal of an existing fire hydrant.
- C. The applicant is advised that there is an existing Letter of Credit (default date 8/1/88) outstanding which guarantees the construction of a sidewalk and curb across vacated Lorraine on Lewis Street (S/D 77-82). As of the writing of these comments, the required construction has not been completed. With the following in mind, the applicant shall submit a new/or amended Letter of Credit which references the following:
 - 1. A new completion or default date of August 1, 1990.
 - 2. A new expiration or negotiation date of October 1, 1990.
 - 3. A dollar amount of \$1738.73 (provides for an 5.25% inflationary factor).

The existing Letter of Credit was submitted when this property was replatted as 400 Lorraine Addition in 1977.

- D. The applicant shall make satisfactory arrangements with KPL Gas Service Company for abandonment of an existing gas line. Once arrangements have been made, a letter shall be obtained from the Gas Company.
