Staff Recommendation: Approve vacation of sanitary sewer easement.

MAPC Recommendation: Approve vacation of sanitary sewer easement. (unanimous)

Background: The construction of a new sanitary sewer line in this general area will replace the sewer line located in the subject easement. The City Engineer's Office has advised that this easement is no longer needed. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

VACATION ORDER

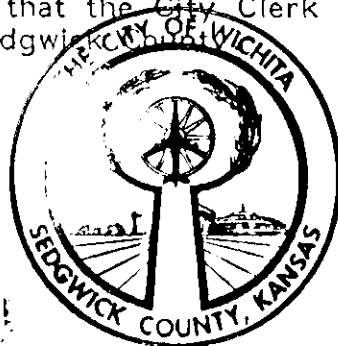
NOW on this 21st day of June, 1988, comes on for hearing the petition for vacation filed by Joyland Hillside Park, Inc., praying for the vacation of the following described portion of a sanitary sewer easement, to-wit:

That part of the 30-foot sanitary sewer easement recorded on Ordinance No. 3318, from the north line of Butler's 2nd Addition, Sedgwick County, Kansas, to the north line of Reserve A and Reserve B in the second replat of part of Pawnee Ranch Addition, Sedgwick County, Kansas. (V-1535)

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on JUNE 8 & 15, 1988.
2. No private rights will be injured or endangered by the vacation of the above-described sanitary sewer easement, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s) the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the sanitary sewer easement described herein should be approved.

IT IS, THEREFORE, BY THE CITY COUNCIL, on this 21st day of June, 1988, ordered that the above-described sanitary sewer easement is hereby vacated. IT IS FURTHER ORDERED that the City Clerk shall certify a copy of this order to the Register of Deeds of Sedgwick County, Kansas.
