Staff Recommendation: Approve vacation of utility and drainage easements.

MAPC Recommendation: Approve vacation of utility and drainage

Background: The purpose of this case is to allow for the construction of a masonry wall around the perimeter of the subject lot. The Utility Advisory Committee has verified that the subject easements are not needed for existing or future utilities. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.
