Staff Recommendation: Approve vacation of utility easement.

Background: This vacation is requested to allow the construction of a house that would encroach into the utility easement. The Utility Advisory Committee has indicated that no adverse effects will result by the vacation of this utility easement. 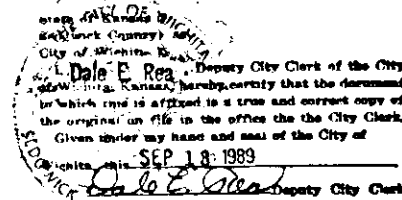

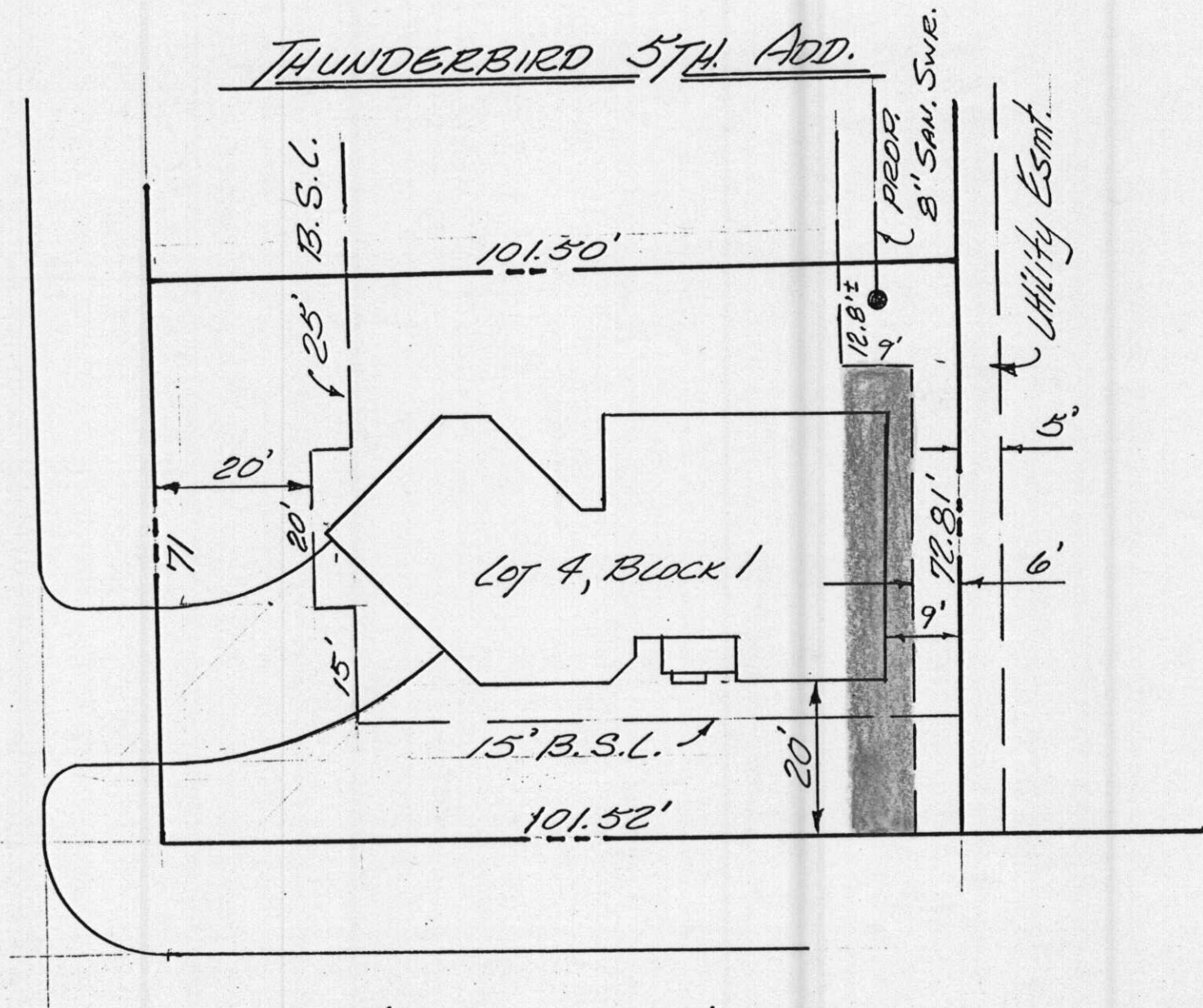
