AN AREA SOUTH OF 13TH STREET NORTH AND WEST OF 119TH STREET WEST
(District #5)

Staff Recommendation: Approve vacation of utility easement.

MAPC Recommendation: Approve vacation of utility easement. (unanimous)

Background: An existing home has been found encroaching the utility easement. The easement was platted as 20-feet wide, but City Engineering indicates that no sanitary-sewer line is located within this easement. The Utility Advisory Committee has indicated that no adverse effects will result by the vacation of the portion of easement involved in the encroachment. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:
