PLATTED BUILDING SETBACK, LOCATED SOUTH OF 29TH ST. SOUTH
AND WEST OF WEST STREET.
(District #4)

INITIATED BY: Metropolitan Area Planning Department

Staff Recommendation: Approve vacation of building setback.

MAPC Recommendation: Approve vacation of building setback.
(unanimous)

Background: The applicant, United Parcel, is requesting a 30 feet vacation of a 35 foot platted setback for an area to construct a wash tunnel for its trucks. U.P.S. wishes to maintain a minimum 35 foot area between the wash tunnel and building to allow their trucks to back into garages. City Engineering and the utility companies have indicated their approval of this vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:
