AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of platted lots, streets,
easements and building setbacks.

MAPC Recommendation: Approve vacation of platted lots, streets,
easements and building setbacks. (unanimous)

Background: This vacation is a requirement for the platting of the Beacon Hill 2nd Addition. This plat is itself a replat which is proposing the vacation of Bleckley St. and would result in platted lots not having public access. This vacation will eradicate those lots not having public access. A replatting of this overall area is in progress which will eventually restructure most of this area's originally proposed development. Substitute utility easements are being provided by the Beacon Hill 2nd plat. The Utilities and City Engineering have indicated that this vacation will have no adverse effects. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

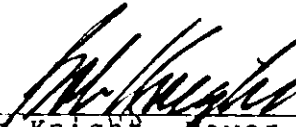
The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

5. The vacation of the platted lots, streets, easements, and setbacks described herein should be approved.

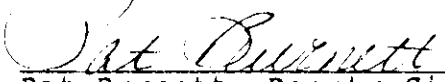

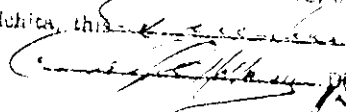

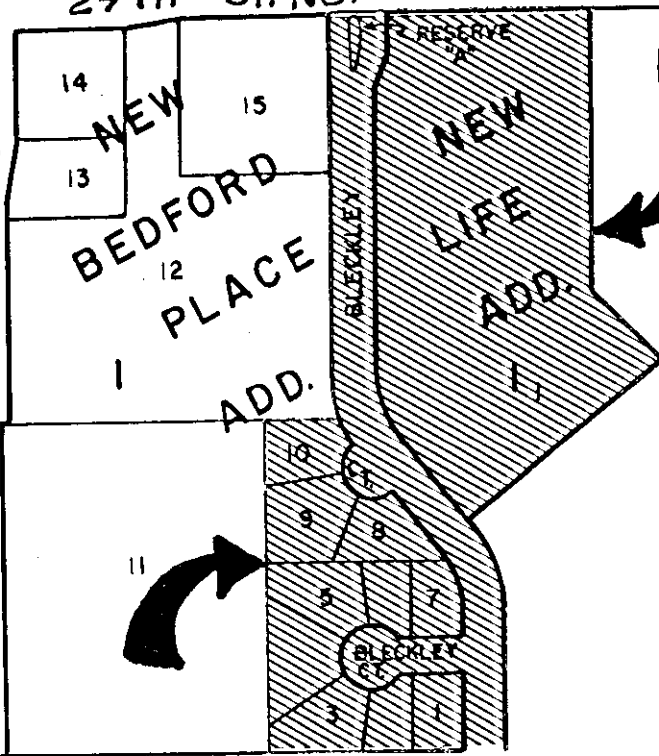
