SUBJECT: PUBLIC HEARING V-1681 - REQUEST TO VACATE PORTIONS OF
PLATTED BUILDING SETBACKS LOCATED SOUTH OF 21ST STREET NORTH
IN AN AREA WEST OF TYLER
(District #5)

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of building setbacks.

MAPC Recommendation: Approve vacation of building setbacks.
(unanimous)

Background: When this area was platted as the Jamesburg Park Addition, several corner lots adjacent to 21st Street North were platted without side yard setbacks. Homes subsequently were built that observed the 6-foot side yard setbacks established by zoning. However, a note on the plat implies that 15-foot side yard setbacks were to be observed for corner lots. While certain title companies originally interpreted that the involved lots were properly observing setbacks as under zoning, recent interpretations by some Title Companies are now indicating that existing homes are encroaching a platted setback. In order to remove the cloud on these properties, this vacation is proposing to reduce any setback considered as established by the plat, to a 6-foot side yard setback or what would exist under zoning for these lots. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

AND

The south 9 feet of the 15 foot setback, as platted, along the north line of Lot 1, Block A, Jamesburg Park an Addition to Wichita, Sedgwick County Kansas, except for the west 25 feet thereof.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on SEP 19 1990 SEP 26 1990
2. No private rights will be injured or endangered by the vacation of the above-described building setbacks, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the building setbacks described herein should be approved.
