Staff Recommendation: Approve vacation of minimum building pad
elevation.

MAPC Recommendation: Approve vacation of minimum building pad
elevation. (unanimous)

Background: This Addition was originally platted with minimum
building pad elevations of 1341 feet mean sea level (MSL). According
to present standards, City Engineering has indicated that 1339 feet
MSL is appropriate for this location. The vacation order will
therefore vacate the present minimum building pad elevation while
retaining the new level. The vacation request has been reviewed and
approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper
notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation;
authorize the Mayor to sign the Vacation

2. No private rights will be injured or endangered by the vacation of the above-described minimum building pad elevation, and the public will suffer no loss or inconvenience thereby.

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation order shall retain a minimum building pad elevation of 1339 feet mean sea level.
6. The vacation of the the minimum building pad elevation described herein should be approved.
