Background: The applicant seeks to vacate a portion of a drainage easement that currently exists along one of the lot lines, with the intention of increasing the amount of available buildable area for a single-family house. Staff and MAPC have recommended approval because City Engineering has indicated that no adverse effects are anticipated by the reduced amount of drainage easement.

This vacation has been reviewed and approved by the Planning Commission, subject to conditions and recording within 30 days.

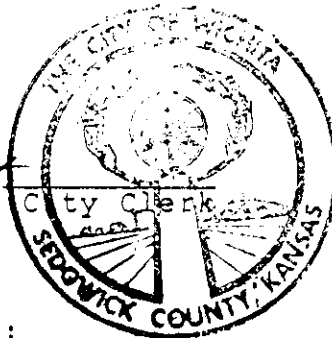

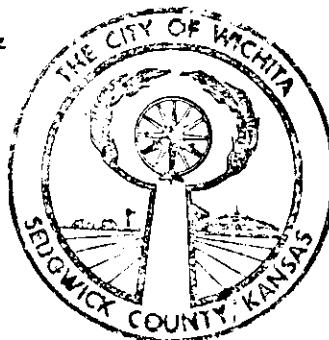


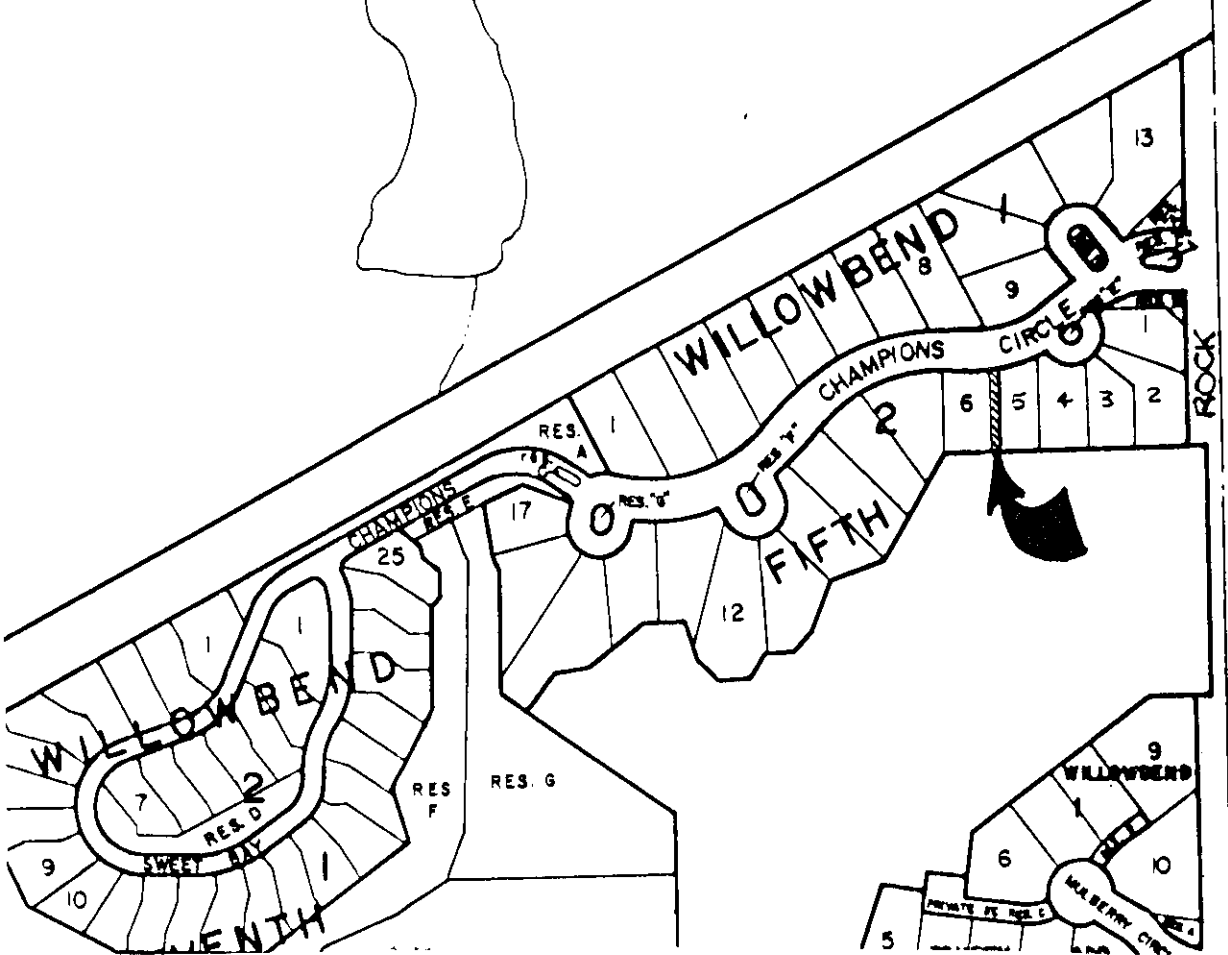
