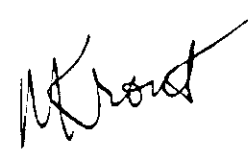

Background: This easement was originally granted to the City and was used for a sanitary sewer force main. This sewer has, however, been abandoned and both City and County Engineering indicate no need exists any more for the easement. Also no other utilities are involved. The applicant desires to install fencing and other improvements which would not be allowed if an easement existed. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Vacation Order; recording costs to be billed to:

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.

5. The vacation of the utility easement described herein should be approved.

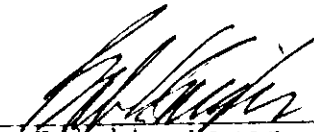
