Staff Recommendation: Approve vacation of utility easements.

Background: The applicant wishes to vacate the easements so that a unified building site, unencumbered by these easements, can be created. Arrangements have been made for the relocation of some utility lines and a substitute easement has been submitted to allow for any future need to extend sanitary sewer to the site. City Engineering and the utilities have indicated that they have no objection to the vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Accept the substitute utility easement and record the easement; close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

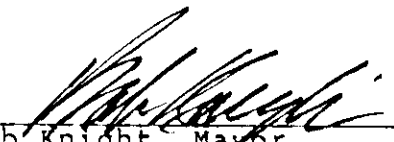
2. No private rights will be injured or endangered by the vacation of the above-described utility easement, and the public will suffer no loss or inconvenience thereby.

3. In justice to the petitioner(s), the prayer of the petition ought to be granted.

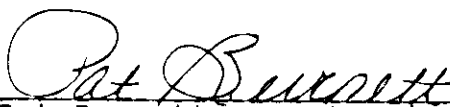
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.

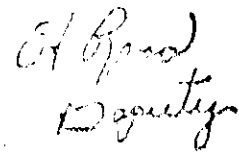

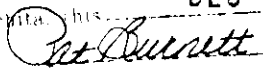
