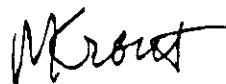

Staff Recommendation: Approve vacation of portion of utility
easement.

MAPC Recommendation: Approve vacation of portion of utility
easement. (unanimous)

Background: While this property (lot) is over 223 feet deep approximately the eastern 130 feet is encumbered by a utility easement. Standard utilities are located in the more or less 20 westerly feet of this easement, with a large, 60 inch sanitary sewer disposal line in the eastern portion. City Engineering and the utilities have agreed, however, that a central portion of this easement can be vacated to allow the applicant to construct a garage. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record certified copy of Order, recording costs to be billed to:

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.

5. The vacation of the utility easement described herein should be approved.
