SUBJECT: PUBLIC HEARING V-1819; REQUEST TO VACATE STREET RIGHT-OF-WAY,
GENERALLY LOCATED SOUTH OF KELLOGG AND EAST OF GREENWICH
(District #2)

INITIATED BY: Metropolitan Area Planning Department *W. Kront*

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of street right-of-way.

MAPC Recommendation: Approve vacation of street right-of-way. (unanimous)

Background: This is the vacation of the remaining Brundige Street right-of-way. As a condition of platting One Kellogg Place (originally submitted as One Greenwich Place), located immediately adjacent to the west line of Brundige, the western half of street right-of-way for Brundige was vacated through the platting process. As a requirement of platting, the applicant now seeks to vacate the [remaining] east half of Brundige, from the centerline, which is adjacent to applicant's property. However, the east 15 feet of this proposed vacation area (i.e., - the east 15 feet of the east half-street right-of-way) is to be retained by the City as public utility easement for the provision of City water services, and the north 56 feet of half-street right-of-way is to be retained as street right-of-way for Kellogg. Staff and MAPC have recommended approval because future development needs have been considered, for utilities and right-of-way, and the vacation will not adversely affect the public interest.

The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions:

Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order; recording costs to be billed to:

VACATION ORDER

NOW on this 29th day of March, 1994, comes on for hearing the petition for vacation filed by Ed Ray, President, Sedgwick State Bank, praying for the vacation of the following described portion of street right-of-way, to-wit:

The east half of Brundige Street right-of-way, as platted in the East Kellogg Mini Storage Addition, an Addition to Wichita, Sedgwick County, Kansas, except the east 15 feet which is retained as public utility easement for the provision of City water, and except the north 56 feet which is retained as street right-of-way for Kellogg.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on 3/11/94 + 3/18/94.
2. No private rights will be injured or endangered by the vacation of the above-described portion of street right-of-way, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The east 15 feet of the above-described street right-of-way being vacated shall be retained as public utility easement for the provision of City water.

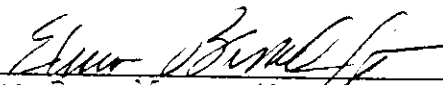

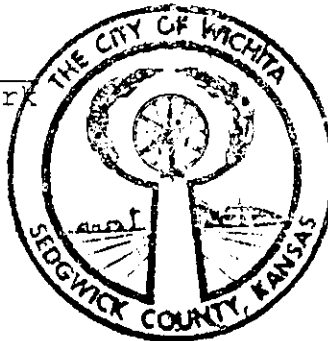
6. The vacation of the portion of street right-of-way described herein should be approved.
