Staff Recommendation: Approve vacation of alley.

MAPC Recommendation: Approve vacation of alley. (unanimous)

Background: The applicant desires to vacate an alley so that the closed alley may be used as part of the Wichita Indochinese child care center. The alley right-of-way will be retained as a utility easement as well as an additional two (2) feet along the north line of the eastern portion of the alley. The applicant will be closing the existing alley openings at Poplar and Green. The north-south alley which appears to dead end into the requested alley vacation was vacated several years ago. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions: Accept the utility easement, close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order, and utility easement recording costs to be billed to: 150029-2909

4. The above described alley right-of-way shall be retained as an utility easement.

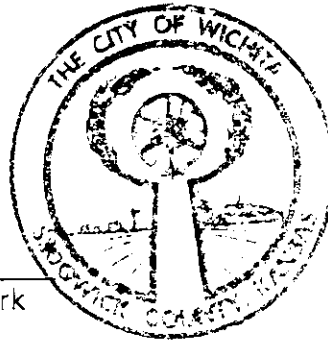
5. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
