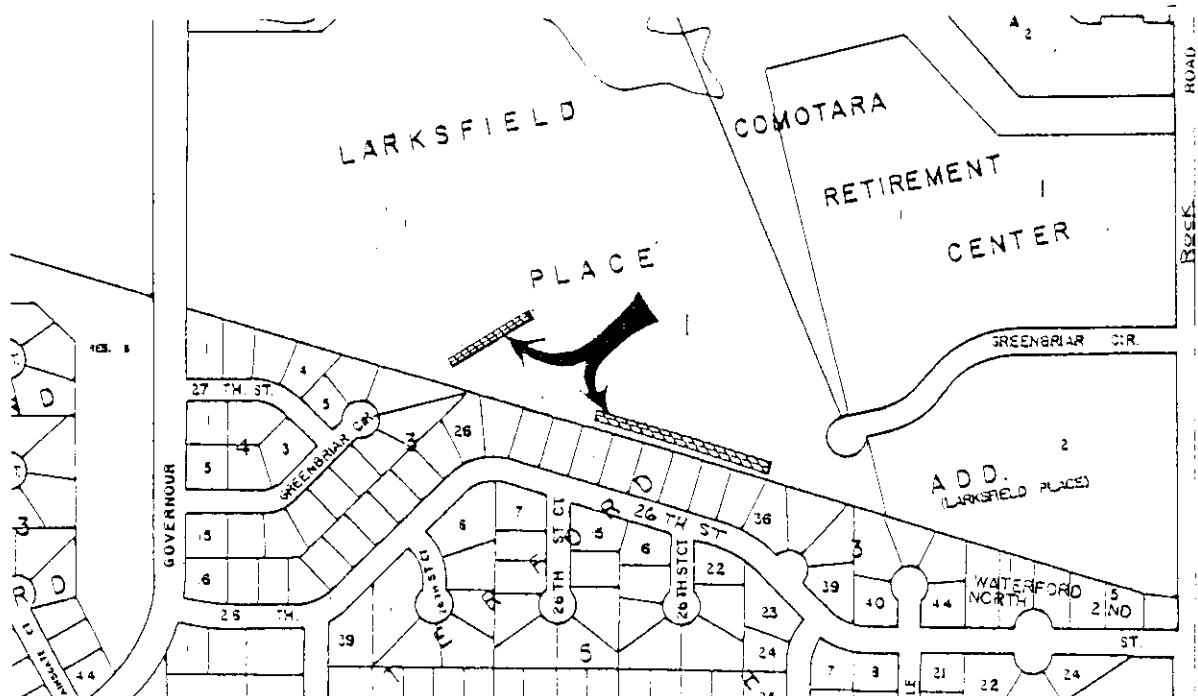
LEGAL DESCRIPTION: The following described drainage easements:
A tract of land lying in the Northeast Quarter, Section 6, Township 27 South, Range 2 East of the 6th P.M., Sedgwick County, Kansas, more particularly a 25 foot tract of land with a centerline described as follows: Commencing at the Northeast corner of the said Northeast Quarter; thence S 34°19'48"W, 1902.57 to the point of beginning; thence N 74°37'52"W, 461.13 feet; to the point of termination. This being a portion of a drainage easement as platted in the Larksfeld Place, An Addition to Wichita, Sedgwick County, Kansas, and
A tract of land lying in the Northeast Quarter, Section 6, Township 27 South, Range 2 East of the 6th P.M., Sedgwick County, Kansas, More particularly a 20 foot tract of land with a centerline described as follows: Commencing at the Northeast corner of the said Northeast quarter; thence S 54°18'58"W, 2297.52 to the point of beginning; thence N 56°13'54"E, 244.42 feet; to the point of termination. This easement having been granted by separate document and being more specifically indicated as Line 1 of this document and as recorded on Film 912, page 319.

LOCATION: South of 29th Street North and west of Rock Road

REASON FOR REQUEST: Additional area needed for planned housing

CURRENT ZONING: "AA" One-family and "B" Multi-family

NOTE: The vacation involves two (2) drainage easements. One request involves a portion of a platted easement while the other easement was apparently granted by separate instrument some time after the property was platted.
