Staff Recommendation: Approve vacation of a portion of a utility easement.

MAPC Recommendation: Approve vacation of a portion of a utility easement. (unanimous)

Background: The applicant is requesting the vacation of a portion of this easement in order to provide additional buildable area. A sanitary sewer line is located in this easement, but is in the southern half and according to the City Engineer will not be impacted by the portion being vacated. Additional utility easement is also available on the lot to the south, and the utility representatives of the Subdivision Committee sufficient easement will still be available following the vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Close the public hearing, approve the vacation;
authorize the Mayor to sign the Vacation Order; and

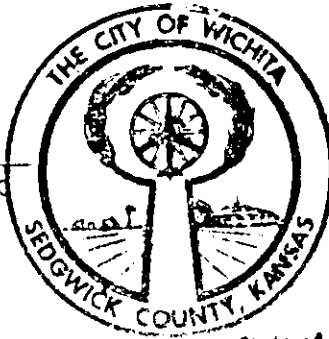

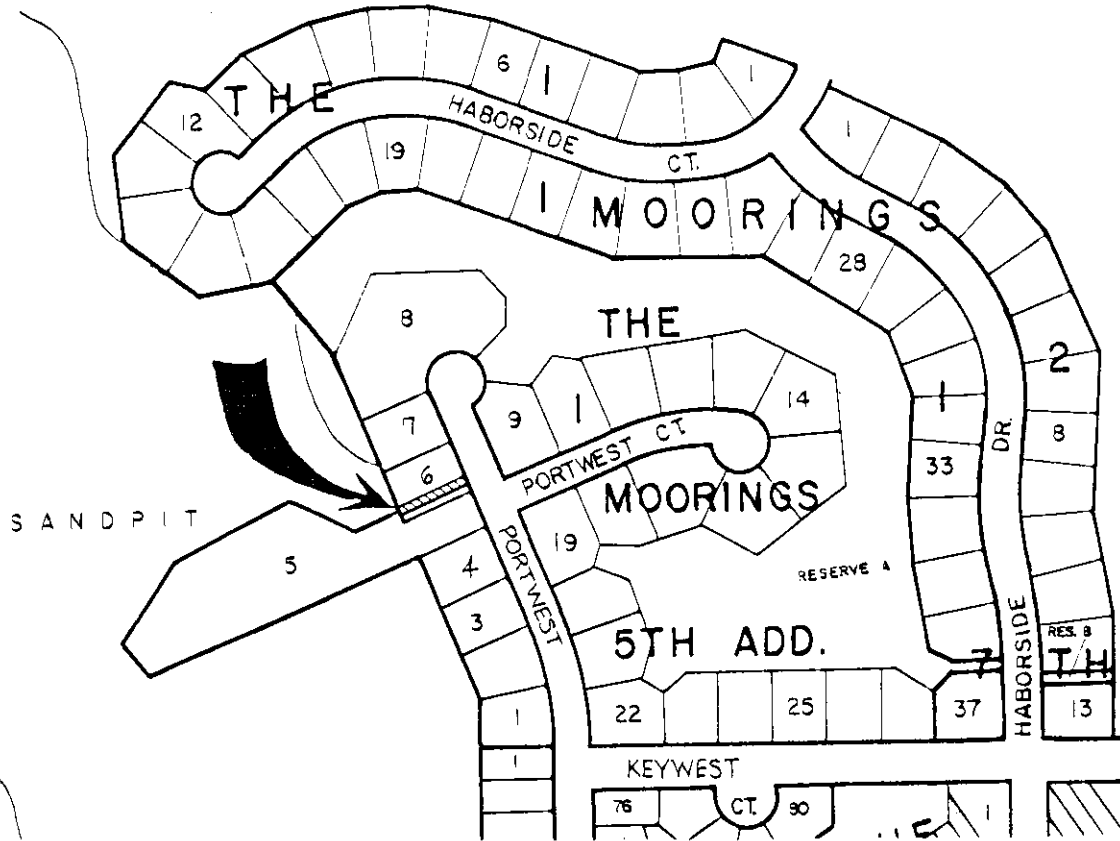
