SUBJECT: PUBLIC HEARING V-1863 REQUEST TO VACATE A PORTION OF A
PLATTED BUILDING SETBACK AND UTILITY EASEMENT LOCATED WEST
OF RIDGE RD. AND NORTH OF 13TH ST. NORTH
(District #5)

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of building setback and utility easement.

MAPC Recommendation: Approve vacation of building setback and utility easement. (unanimous)

Background: A recent zone change to "C" commercial zoning was approved for this site in order to allow for installation of a baseball batting cage facility. However, a portion of the site encumbered by a building setback and utility easement. Consequently, to build the batting cage, a vacation of this setback and easement is also needed. While City Engineering indicated that a sewer line is in the easement area, it was far enough away so as not to be impacted by the vacation. In regards to the building setback, the Subdivision Committee and Planning Commission felt that no negative impact would result. As a requirement of the zoning case, a covenant was required, limited how the area of the zone change and vacation could be used. This covenant has been submitted for recording with this vacation case.

The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions: Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order and Restrictive Covenant; recording costs to be billed to:

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
