Staff Recommendation: Approve vacation of building setback.

MAPC Recommendation: Approve vacation of building setback. (unanimous)

Background: The applicant wishes to vacate a portion of a platted building setback in order to clear the title to this property. A corner of the house on this lot was inadvertently constructed approximately 1 1/2 feet into the 25 foot front yard setback. City Engineering and the utility representatives of the Subdivision Committee have indicated that no facilities are impacted by the vacation. No members of the public addressed MAPC in opposition to this request.

The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions:

Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order; recording costs to be billed to: 150029-2909

VACATION ORDER

NOW on this 4th day of February, 1997, comes on for hearing the petition for vacation filed by James Frey and Nancy Kitchens, praying for the vacation of the following described building setback, to-wit:

Commencing at the northerly front corner of Lot 30, Block 4, Bay Country, an Addition to Wichita, Sedgwick County, Kansas; thence N61° 43' 36"E along the northwest line of said Lot 30, 25 feet to the intersection with the 25 foot building setback line as platted in said Lot 30; thence southerly along said setback line, having a central angle of 12° 43' 36" and a radius of 75 feet, an arc distance of 16.66 feet, (having a chord length of 16.62 feet bearing S21° 54' 36"E), to the point of beginning; thence continuing southerly along said setback line, having a central angle of 9° 37' 34" and a radius of 75 feet, an arc distance of 12.60 feet, (having a chord length of 12.59 feet bearing S10° 44' 01"E) thence S87° 39' 38"W, 1.84 feet; thence N02° 20' 22"W, 12.45 feet to the point of beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on 1/22/97 & 1/29/97.

2. No private rights will be injured or endangered by the vacation of the above-described building setback, and the public will suffer no loss or inconvenience thereby.

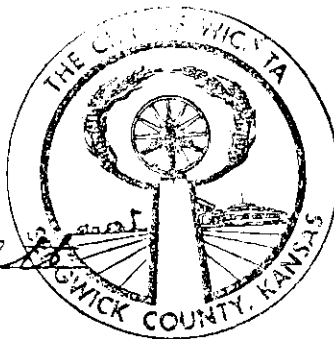
