SUBJECT: PUBLIC HEARING V-1989 REQUEST TO VACATE A DETENTION AREA
AND DRAINAGE EASEMENT LOCATED IN AN AREA SOUTH OF 31ST
STREET SOUTH AND EAST OF HYDRAULIC
(District #3)

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of a detention area and drainage easement.

MAPC Recommendation: Approve vacation of a detention area and drainage easement.
(unanimous)

Background: The applicant wishes to vacate the platted detention area and drainage easement so that they may gain use of this portion of their property for locating structures associated with their planned development of this site. Upon vacation of the existing easement, a new drainage easement, in accordance with the revised approved drainage plan, will be granted to the city in a location more suited to the applicant's development plan. Both City Engineering and the utility representatives of the Subdivision Committee indicate that no facilities are located in the easement and the revised drainage easement on the site is adequate to serve the area. Therefore, the drainage easement may be vacated so as to allow the applicant to develop in this area.

The vacation request has been reviewed and approved by the Planning Commission, subject to conditions. No members of the public addressed the MAPC in opposition to this request.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions: Accept the dedication of drainage easement; close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order and the dedication of drainage easement; recording costs to be billed to: 150029-2909

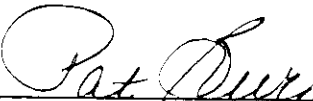

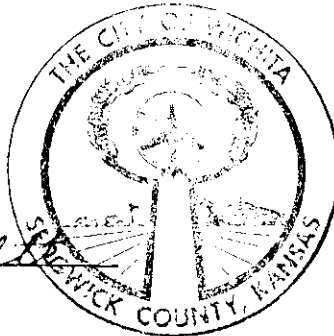

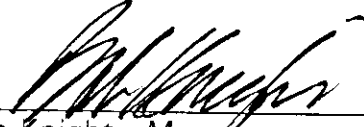
5. The vacation of the detention area and drainage easement described herein should be approved.

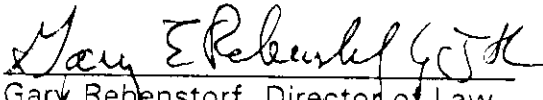

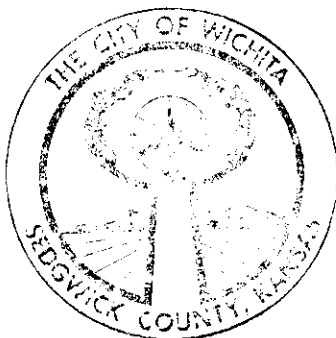
