Staff Recommendation: Approve vacation of fire lane easement.

MAPC Recommendation: Approve vacation of fire lane easement. (unanimous)

Background: The Sweetbriar Shopping Center, when originally platted, provided a fire lane within an easement to provide assured access between proposed buildings within the center. Subsequently, plans have been changed in the configuration of the buildings. The Fire Department is working directly with the owners to assure accessibility of fire equipment in and around the proposed buildings. This is being done through the permitting process and it has been determined that the fire lane easement is both a restriction in the design and layout of the buildings, as well as no longer being needed.

The Subdivision/Utility Committee and the MAPC both recommended the vacation be approved. No members of the public spoke in opposition to this request.

Recommendations/Actions: Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; record the certified copy of the Vacation Order, recording costs to be billed to:

2. No private rights will be injured or endangered by the vacation of the above-described fire lane easement, and the public will suffer no loss or inconvenience thereby.

5. The vacation of the fire lane easement described herein should be approved.

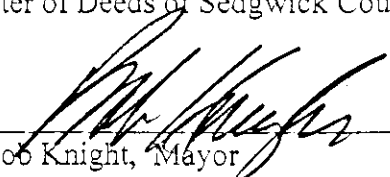

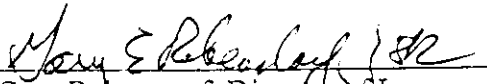

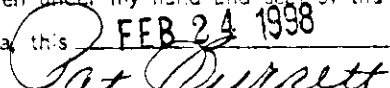
